- 2. If no EMS personnel sign on the air, prior to attempting mutual aid, add the appropriate fire company as first responders and hold off on mutual aid until contact is made. FD is added only if no one from NVAC signs on.

The BOFC will reach out to NVAC to set up and meeting for discussion on the Fire Departments concerns.

NEW BUSINESS: Added: Brian Sharnick made a motion to purchase of 3 sets of gear for NH&L for members in FF1 Jay Nezvesky seconded the motion passed.

Added: Tim Whelan made a motion for reimbursement to Sandy Hook for the upgrade to all LED lighting to the station- Tim presented 3 Quotes and the least is in the amount of \$8,500.00. Ron Bolmer seconded the motion and the motion passed.
