### REPORTS

Chair Report (Attachment A)— A. Weidemann announced that B. Edwards has resigned from the COA.

*Vice Chair, Grant* – A. Rothstein is looking into AARP to see if that will cover any of the lunch program. She asked how much money is needed. N. Jackson will work up an estimate. C. Symes questioned if the grants will dry up moving forward? A. Rothstein replied that she does not think that will be the case. Grants are separate from budgets and many companies have foundations so they cannot roll up and go away.

Director of Human Services update – N. Jackson reviewed her report (Attachment B). They did run their membership numbers, 401 are residents and 36 out of town for a total of 437 members.

First Selectman update - None

Treasurers Report (Attachment C) – It is the same as last month, no deposit or expenses.

J. Albanese moved to approve the treasurer's report for audit. B. Bloom seconded, all in favor.

*Update on Social Justice, Kindness and Racism:* Reviewed his presentation (Attachment D). L.Levitt suggested that members look at biocinewtown on Instagram which is all Newtown run by Newtown kids. It shows the inequality, and racism in the school system.

*Member comments* – L. Levitt announced that the Alzheimer's Associated of CT is having their conference from April 7 to 9, 2021. On April 9<sup>th</sup>, there is a free caregiver of Alzheimer's conference that maybe useful to caregivers.

L. Passaro advised anyone who had unemployment wait another week to file. They have now made \$10,200 of unemployment tax free but the software out there has not been updated.

Having no further business, <u>L. Passaro moved to adjourn the meeting at 5:02pm. B. Bloom seconded</u>, all in favor.

It's a step, he hopes that will help foster conversations so that Newtown can become less divisive about this issue and all issues. Constructive discussion is important to learning.

### Commission on Aging Report: March 15, 2021

Efforts to vaccinate our senior community continue at the Senior Center. To date, over 2,000 vaccines have been administered in Town. According to ct.gov, 99.45% of Newtown residents 75+ have received the vaccine and 75.1% of that population statewide have received at least the first dose. On March 22<sup>nd</sup> the State opens eligibility to individuals 45 to 54. The Human Services team continues to be an initial point of access for support to seniors who need assistance registering for the vaccine, or have questions about the process.

Newtown Human Services continues to work with the Health District to be the clinic site for our senior residents. We hope to continue be the vaccine site until we reach residents through age 55. The town's rollout began with our oldest residents, 100+ and we continue to work our down our list of residents who have preregistered. Last week we scheduled residents ages 63+. As we continue to reach out directly to preregistered residents by phone to schedule we are finding that a significant portion of our seniors have found opportunities to receive the vaccine at a site out of Town through VAMS. In effort to vaccinate the community as quickly as possible we continue to encourage residents to utilize VAMS.

At this time all in-house programs continue to be on hold to allow for clinics. All Health & Wellness classes and socialization groups are continuing via Zoom. Our COVID curbside lunch program on Mondays and Wednesdays also continues with our new partnership with Whitsons Culinary Group. Per a call with WCAAA last week, funding for meals may resume in April or May. We will be exploring the option of returning to CW Resources as well as the potential to utilize funding in a way that allows us to continue with Whitsons. As we learn more I will continue to share information on this.

I am thrilled to share that this afternoon I will be joining representatives from Newtown Helping Hands to present a check to FAITH Food Pantry for 100% of remaining funds raised through this effort at the start of the pandemic. This last disbursement of monies, in the amount of \$6,496.21, to FAITH will assist in the continued relief of essential food in Newtown. Newtown Helping Hands was a successful cooperation between partnered groups, restaurants, and volunteers. Keep as eye out for an upcoming article in the Bee, highlighting:

- Restaurants involved

- Estimated # of volunteers
- Estimated community service hours
- Total grocery shopping deliveries
- Total monies raised / # of donors
- Total meals distributed to families and frontline healthcare workers at Newtown Rehab.
- Special food drive collection sponsored by WIN

# **Terminology & Definitions**

Kindness – an expression or demonstration of friendship, Inclusion – accepting, not excluding different views Social – pertaining to society and its interactions Diversity – meaning a broad, inclusive audience Racial – having to do with different ethnicities Equity – having to do with fairness and justice Justice - legal application of fair judgement Equality – treating all things equal White, Black, Brown, Red, Yellow empathy, compassion

### **Challenges**

Across 2020 and into 2021 we continue to be horribly reminded of Anti-Black, Brown, Red and Yellow biases latent within our nation the harsh realities of Political Divide, Racism, White Supremacy,

Police Brutality, Killings and Shootings around the country, and the Zoombombings, it highlights the need for a return to some degree This is not a new phenomenon, but coupled with the ongoing of equitable Social-Racial Justice

Disparity that I saw in high school in the 1960s still exists in schools The Civil War of 1861-1865 and various Legislation-Amendments were supposed to ensure Equal Rights, however, the Racial today! The past riots of Chicago, Newark and Los Angeles further exemplify the underlying Social-Racial-Health-Economic problems
