Introduce Nicole Camporeale our newly appointed COA Alternate Member – Members went around the table introducing themselves.

Kaki Taylor to introduce Jennifer Nash, the new Assistant Director of the CH Booth Library – K. Taylor introduced J. Nash as the new Assistant Director of the CH Booth Library.

Minutes – B. Bloom moved to approve the minutes from the 4/19/21 meeting with the correction on third motion "L. Passaro moved to table discussion about forming a group until the next meeting. L. Frampton seconded, motion passes" (8 Yes) should be (7 Yes). L. Frampton seconded, all in favor.

Vice Chair, Grant - No update

Director of Human Services update—N. Jackson reviewed her report (Attachment B).

First Selectman update — First Selectman Rosenthal reported that normalcy seems to be coming back and sooner than most thought it would. In the beginning of the year they thought end of the summer and now we are talking mid-May. C. Symes reported that he, A. Wiedemann, and J. Boccuzzi, met with First Selectman Rosenthal regarding senior transportation. First Selectman Rosenthal suggested doing a survey. He explained that they need this to see for certain what the demand is. L. Frampton explained that she has been involved with Nunnawauk Meadows for years and the only problem they have seen in transportation for large wheelchairs. They had HART come to talk to residents but very few people attended. A. Wiedemann explained that FISH only received 2 calls for transportation during the shutdown.

Treasurers Report (Attachment C) – L. Passaro reported that once again there are no changes since March. He pointed out that the crafters have contributed \$2,945 to the gift fund this year. <u>L. Frampton moved to send the treasurers report to audit.</u> B. Bloom seconded, all in favor.

Volunteer Opportunity/Age Well Ambassador (Attachment D) – R. Ryles explained that part of the program is to train ambassadors to identify food insecure seniors and help them. There is online training is June 2 and 3^{rd} .

Discussion and possible action regarding the Arts Festival – J. Albanesi moved to authorize payment of \$50 for participation at the Arts Festival. L. Frampton seconded, all in favor.

MEMBER COMMENTS – L. Levitte reported that Governor Lamont signed Senate Bill 817, "An Act Concerning Senior Centers and Senior Crime Prevention Education". A. Wiedemann invited Senator Tony Hwang and State Representative Mitch Bolinsky to come to the next COA meeting. L. Passaro reported that the Chamber of Commerce will be sending out a constant contact to all their members to get a classification for their business. Based on that feedback, they will proceed on making phone calls.

Having no further business, <u>C Symes moved to adjourn the meeting at 3:49pm. B. Bloom seconded, all in favor.</u>

Commission on Aging Report: May 17, 2021

Through the Newtown Health District over 4,000 COVID 19 vaccines were administered in Town. Together the Health District staff and DHS team were able to reach out to all residents 55 and over who had preregistered to receive the vaccine through the Health District. Residents who had not already received the vaccine elsewhere were able to come into the Senior Center for their first and second doses. With that effort now complete we are excited to report...the Senior Center is back open for business!

It has been wonderful to having our members back in house for classes and groups. We have also continued to offer classes and events virtually so members can participate in the format that they are most comfortable. As the weather warms and we move into summer we are looking forward to offering more events outdoors. Planning for a summer concert to celebrate July 4th is in full swing in partnership with Parks & Recreation. It is exciting to be planning events to bring our community together again, safely and in person!

The Senior Center crafters continue to be very busy with their Pop-up Boutiques at the Community Center. Not being able to hold the traditional, annual Bazaar didn't deter them! Please stop by and see their amazing creations this coming Saturday, the 22nd, at the Community Center between 8:00 and 2:00. All proceeds from their sales go directly back to the Senior Center gift fund.

Just a reminder that Renters Rebate applications for this year are open. Persons renting an apartment or room, or living in cooperative housing or a mobile home may be eligible for this program. Renters' rebates can be up to \$900 for married couples and \$700 for single persons. The renters' rebate amount is based on a graduated income scale and the amount of rent and utility payments (excluding telephone) made in the calendar year prior to the year in which the renter applies. Applications will be accepted through October 1st. Seniors can apply by contacting Human Services at 203-270-4330.

- Be willing to attend monthly meetings for the first few months, and be able to commit to the program for one year.




