**Public Comment** – Assistant Director of CH Booth Library J. Nash reported that they have their Memory Café the first Monday of the month. This month the Bruce Museum will be presenting "Lifetime of Looking" an art appreciation program (Attachment A). They also have a Warming Earth Book Club based on climate change (Attachment B). And finally a series of retirement/Medicare retirement presentation (Attachment C).

Minutes – <u>L. Frampton moved to approve the minutes of the July 18, 2022 meeting.</u> <u>B. Bloom seconded, all in favor.</u>

Chair Report – A. Rothstein thanked all the volunteers that helped out at the Arts Festival. They collected emails from people that are not members of the senior center. Those people received a magnet with a flower on them which was a photo from a talented photographer. She also explained that they are donating a few photo albums of his that are sorted by country in the hopes that seniors will be able to enjoy them.

Treasurer's Report – <u>L. Frampton moved to send the Treasurer's report (Attachment E) to audit.</u> J. Geraci seconded, all in favor.

#### OLD BUSINESS

Lunch Program Review – L. Frampton explained that they have gotten some donations which allows them to continue to charge \$3 per lunch. They are starting to run low on funds and will need to start fund raising again. Seniors arrive 30 minutes before lunch to socialize and get fresh food. L. Frampton will continue to do the lunches Monday and Wednesday through the middle of October. Once the vendor starts she will only do Monday's.

#### Report on Arts Festival - Discussed in Chair Report

#### **NEW BUSINESS**

Funding of \$300 to subsidize a senior pottery class this fall at the Community Center – The cost of the class is \$80 per person so there is still an out of pocket expense. FONs will be subsidizing \$225 for the class as well. L. Frampton moved to approve \$225 to subsidize the cost of the pottery class this fall along with \$225 from FONS. N. Camporeale seconded, all in favor.

On behalf of the Senior Center and Community Center, funding up to \$250 for a DJ at the Senior Sock Hop in September at the Community Center – L. Passaro moved to approve \$250 for a DJ at the Senior Sock Hop. L. Frampton seconded, all in favor.

Suggestions for speaker topics for 2022-2023

Internet Safety - A. Rothstein said there are people at the bank that deal with this all the time and they are willing to come and speak.

Other – Other suggestions were Mythis of Dementia, Glass bead demonstration, How people with disabilities are treated, Bonzo the Clown and Home Fit, which will be doing a presentation at the October COA meeting. J. Destefano suggested polling the seniors to see what they would be interested in.

What a wonderful weekend at the Newtown Arts Festival! The COA/Senior Center table got a lot of traffic and our Line Dancers were a hit preforming to close out the event! Thanks to our COA Chair, Anne Rothstein, we had volunteers circling through to staff the table over the entire event, including Senior Center members and some of our COA— and a special thanks to Anne also for being at the event from set-up to breakdown. We were able to display the some of the work by members in our art classes as well as many of the Crafter's wares. There was a lot of interest in the items we displayed so I hope that helps draw in shoppers to our upcoming Popup Boutiques. Please spread the word about the boutique days:

#### The Senior Center Lunch Program:

I want to thank LeReine Frampton for being at the Senior Center over the past several months for *Lunches with LeReine*. The volunteer time that LeReine has put in is immeasurable—from shopping and prepping on Sundays to full days in the kitchen preparing and serving. The lunches have been a tremendous success, ranging from 25-40 diners each lunch day. Thank you also to the many volunteers that have stepped up to help LeReine take this on. It has been no small endeavor and is very appreciated by the lunch crew.

#### Senior Center Membership:

July 1 marked the new membership year for the Senior Center. Thus far we have 483 22/23 memberships, 127 of which are first time members! I think it is also important to note that we have 1028 contacts receiving our email blasts.

#### Programming at the Senior Center:

Despite an open position at the Senior Center we maintained a very busy program schedule for the summer months. Thanks to Jennifer Faircloth and also to Jennifer Cebry, who returned to help us in the interim, I don't think the Center skipped a beat. I will look forward to introducing you to our new Senior Center Assistant at our next meeting. She will be starting in her new role next Monday.

#### Social Services Updates:

Some key updates around our social services programs to note:

Energy Assistance: Connecticut residents struggling to pay their utility bills can apply for home heating assistance at their local Community Action Agency (CAA). Community Action Agencies are the only nonprofit agencies administering the Low Income Home Energy Assistance Program (LIHEAP), a federal program (administered by the CT Department of Social Services) that provides home heating assistance. Homeowners and/or renters may apply, and funds may be used to pay for whatever source of heating residents have in their homes. This includes wood, electric, oil, kerosene, or natural gas. The program is now open and runs thru May 2023. To make an appointment or for questions call Jackie @ 203-270-4331 or Alyssa @ 203-270-4330, or a resident can work directly with Community Action @ 203-744-4700.

Financial Assistance: through the volunteerism of Salvation Army and Newtown Fund and the generosity of the Community we were able to assist families prepare for back to school and households in need at this midpoint in the year with financial and basic needs assistance. Both the Salvation Army and Newtown Fund stepped up to do summer drive for funds. Both groups are now gearing up for their traditional holiday bell-ringing effort (Salvation Army) and holiday gift basket program (Newtown Fund).

**Tutoring Services**: \$100,000 in ARPA funds has been approved to be directed to the Department of Human Services to pay for tutoring services for Newtown students to address the learning gap as a result of the pandemic. A student whose family meets ALICE income guideline for financial assistance will be eligible for up to 16 tutoring sessions over the course of the academic year. Tutors will be existing BOE staff. The program will officially "launch" this week.

The fall is always busy in Newtown. This weekend I hope to see some of you on Saturday at the Newtown Health Fair, back again after its hiatus during COVID, and the 2<sup>nd</sup> annual Senior Center/Community Center Grandparent Sock Hop on Sunday!
