Ms. Salling opened the meeting at 7:31 p.m.

PUBLIC HEARING

Application #20-27 by Negreiro & Sons Construction LLC, property located at 203 & 211 Berkshire Road to construct 15 single family homes and a 1,550 ft. road with associated improvements.

Mr. McCabe read the public notice in to the record. Ms. Salling welcomed the public and described the expectations for the public hearing process.

Ms. Salling gave an overview of the process for Commission site walks. Ms. Salling stated the dates and times of the Commission's site walks for Application IW #20-27. Ms. Salling explained the importance of the site walks. Ms. Salling stated that the site walks are opportunities for the Commission to obtain the details, the orientation and the location of the property. Ms. Salling also explained that the Commissioners meet in small groups which do not substantiate a quorum. The Commissioners only have discussions on their findings at the IWC meetings.

Larry Edwards, Civil Engineer and Land Surveyor, J. Edwards & Associates, LLC, Easton CT represented the applicant, Negreiro & Sons Construction LLC.

Mr. Edwards stated that the Commission had made three requests at the last meeting which he addressed.

- 1. Provide a bond estimate for the mitigation of the wetland creation area. Mr. Edwards noted the bond estimate was submitted to the Land Use Agency on November 18, 2020.
- Provide a detailed construction plan for the wetland crossing. Mr. Edwards gave an overview of the construction plans and noted the plans were submitted to the Land Use Agency on November 23, 2020.

3. Provide a potential alternative layout for the site. Mr. Edwards gave an overview of an alternative plan and noted it would be the same number of lots but would have 3 to 4 times more disturbance to the wetlands.

Mr. Hnatuk thanked Mr. Edwards for the alternative site plans

Ms. Salling thanked Mr. Edwards for his presentation.

The Commission was satisfied with the overview and had no additional questions.

With no further questions from the Commission or public Ms. Salling recommended the public hearing be closed.

Mr. Ferris moved to approve **Application #20-27 by Negreiro & Sons Construction LLC**, with standard conditions A, B, C, D, E, F,H, L, O and P.

Mr. McCabe seconded. All in favor. **Application #20-27 by Negreiro & Sons Construction LLC,** property located at 203 & 211 Berkshire Road to construct 15 single family homes and a 1,550 ft. road with associated improvements was approved.

They agreed the conference had good sessions and was convenient but Mr. McCabe missed the interaction with other people. Mr. McCabe noted that Darryl Newman of Planters' Choice spoke at the conference. Mr. McCabe asked Mr. Hnatuk whether there has been any progress of the remediation plan on the Planters' Choice property. Mr. Hnatuk responded that Mr. Newman

had started working on the creation of the wet meadow this past fall but has no new information at this time.






ADJOURNMENT
