Gary Fillion, chairman, called the meeting to order at 7:02 pm.

#### Secretary's Report:

A motion to accept the minutes as read from the January 8, 2019 meeting was made by Bill May, seconded by Frank Cavallo; the motion was passed unanimously.

#### **Public Comments:**

Several Monroe residents were in attendance to ask questions about weed treatments noting that weeds in the lake adjacent to the area south of Eichlers Cove was very thick with weeds throughout the summer.

# **Publicity/ Public Awareness:**

# Water Quality / Grants Report:

Gary Fillion has asked George Knoecklein, Northeast Aquatic Research, to attend the March meeting to review past weed treatment and options for summer 2019. Gary will be attending meetings with First Light on weeds, debris, First Light's Shoreline Management Plan and other issues in the coming weeks.

Bob Mouchantat suggested two questions for George: is it possible to have interested parties participate, at

their expense, in the weed treatment of areas that are considered more specific than the general navigation of the lake (including Kettletown, Jackson's Cove, Eichlers, the two marinas, community associations/areas) and second, ensuring the timing of treatments is optimal since the initial/large treatment seemed less effective in early June 2018 than years past when treatment was at the end of June.

# **Boats and Motors Report:**

Dick Speer reported boats are stored. He is investigating replacement of VHF radios.

#### **Grants:**

Dick Speer will be working on 2019 First Light Grant.

#### **Unfinished Business:**
