THE FOLLOWING MINUTES ARE SUBJECT TO APPROVAL BY THE PENSION COMMITTEE.

1. Meeting called to order by Chairman Ellen Whalen at 7:37 pm.

Committee Members in attendance: Sam Broomer, Joe Eppers, Charles Farfaglia, Tom Snayd and Ellen Whalen. Absent: Patrick Burke and Paula Wickman

Guest: Devon Francis, Partner and Senior Consultant, Fiduciary Investment Advisors, LLC and David Leonard, Actuary TR Paul Inc

2. Devon Francis, Partner and Senior Consultant, Fiduciary Investment Advisors, LLC

Devon Francis reported on the Asset Allocation Analysis FIA had prepared at the request of the Committee. The discussion centered around maximizing the returns for the Pension and OPEB Trusts. The FIA Frontier Engineer Analysis reflected four different Investment Options noting the Asset Allocation, Forecasts and Past Annualized Returns and Volatility for the period 1/88-9/20 for those Options. The Committee requested Ms. Francis prepare recommended portfolios for review prior to the November PC Meeting.

2. David Leonard, Actuary TR Paul Inc

David Leonard discussed the Interest Rate Impact Study the Committee had requested. The Pension Trust Interest Rate Assumption is presently at 7%. The Study reflected the financial impact of an interest rate decrease to 6.75% or 6.50%. Also, Mr. Leonard discussed the new Society of Actuaries Mortality Tables called Pub-10 that specifically focus on municipal and state employees' pension experience. Mr. Leonard recommends the Actuarial Valuation for July 1, 2020 be based on the Pub-10. The Pension Committee will further discuss the interest rate change and mortality table change at the November Meeting.

4. Minutes

Joe Eppers motioned to approve the minutes of the September 17, 2020 meeting; Tom Snayd seconded. All in favor and motion passes.

5. Correspondence

Ms. Whalen received correspondence regarding the celebration the Town is planning for Veteran's Day. Copy sent to Members

7. Old Business

TR Paul Review Meeting November 19, 2020

Mrs. Whalen advised Committee TR Paul will be invited to the November Pension Meeting November 19th as part of the Committee Governance Service Provider Review.

<u>Mahoney Sabol Update – Conference Call October 8th</u>

Mrs. Whalen advised a conference call with Mahoney Sabol, LLC, Town Auditors took place October 8th. Mike VanDeventer, Partner in Charge of Governmental Services Audits and Mike Sabol, Partner in Charge of Employee Benefit Audits discussed the audit requirements for public pension and other post-retirement plans. Mr. VanDeventer advised Committee Members, Patrick Burke, Sam Broomer, Charles Farfaglia and Ellen Whalen that state and local plans must follow the financial measurement and reporting requirements of the Governmental Accounting Standards Board (GASB). GASB generally requires organizations that administer a pension plan or OPEB plan through a trust or equivalent arrangement report the plans as a fiduciary activity. The Town of Newtown plans meet this requirement and are, therefore, included in the Town's financial statements. The Trust information is part of the Town CAFR for which an opinion is rendered in the Independent Auditor's Report. A separate Audit of the Pension/OPEB Trusts is not required. However, as part of the Committee's Governance Guidelines the Town CAFR is reviewed. A copy of Mr. VanDeventer's email re the Pension/OPEB audit has been provided to all Committee Members and Bob Tait, Finance Director.

Documentation Review – Committee Responsibilities Update

Mrs. Whalen spoke regarding the Pension/OPEB document highlighting the responsibilities of the Committee across all Pension/OPEB documentation, Town Charter and Code. She asked that Members review all documentation but specifically review the documents assigned to them and ensure Pension Committee responsibilities noted in those documents agree with the Committee Responsibility Review Draft.

8. New Business

Pension/OPEB Trust Market Value and Return Update a/o September 30, 2020

Ms. Whalen advised the Committee the Pension Trust Market Value as 9/30/20 was \$51.2 million, the OPEB Trust Market Value as of 9/30/20 was \$3.4 million. Returns QTD -Pension:5.1%; OPEB: 4.9%

OPEB Actuarial Report Review Schedule – Hooker & Holcombe GASB 74-75 Report

Mrs. Whalen spoke with Stephan Churyrida, Actuary, re status of the 6/30/20 OPEB Valuation. He has finalized the OPEB GASB 74/75 Report Copy provided to PC Members. The OPEB actuarial valuation will be begun when census data is received from the Town and BOE. Mrs. Whalen will contact Mr. Churyrida to discuss the interest rate assumption for OPEB.

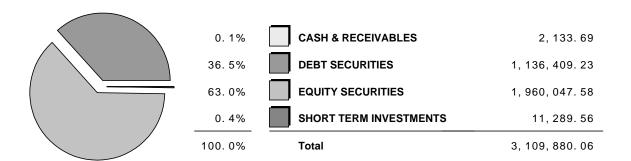

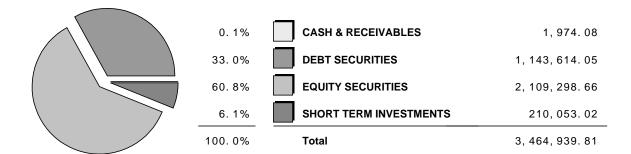

Ending Market Allocation





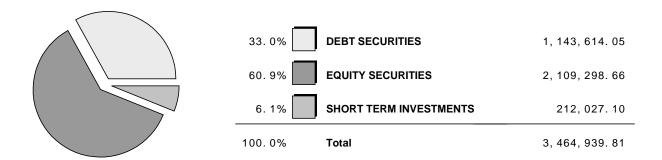

Ending Market Allocation





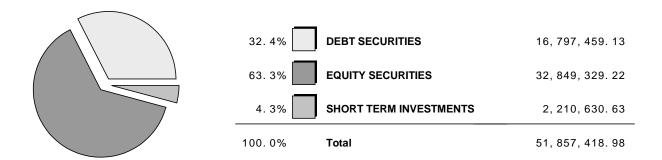

The S&P 500 Index took a step back in September, falling 3.8%. This decline followed five straight months of gains, which saw the S&P 500 rise over 60% from the lows encountered on March 23rd to its most recent all-time high on September 2nd. From a style perspective, value outperformed growth within large capitalization stocks, and growth outperformed within small and mid-capitalization securities. At the sector level, utilities and real estate, often viewed as bond proxy sectors, led the way with positive absolute returns. Conversely, energy and technology were the laggards in the period.

Negative performance for the quarter was largely a result of spread widening, as investment grade and high yield bond spreads increased 7 and 40 basis points, respectively. International bond markets produced negative returns as well, with the FTSE WGBI returning -0.2% in September.

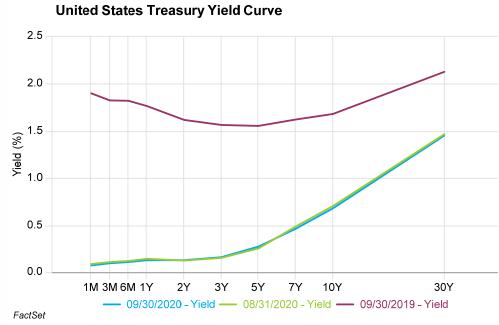

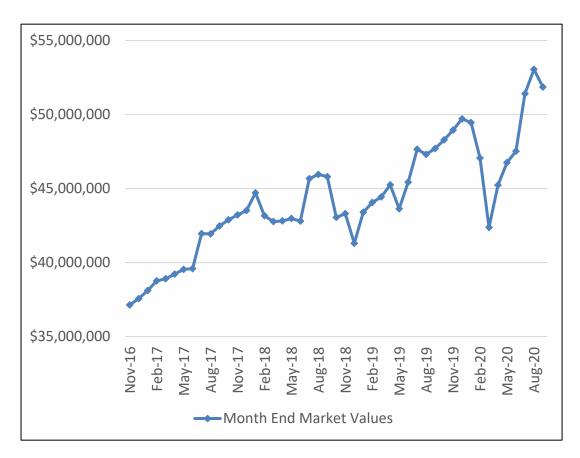

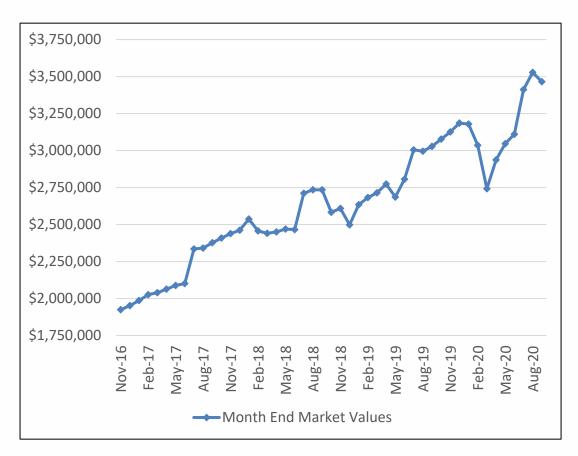
