**Old Business**

Trust/Plan Documentation – Mrs. Whalen asked the Committee if there were any further comments on the revised Adoption Agreement for The Town of Newtown Elected Officials Pension Plan and the Town of Newtown Elected Officials Pension Plan Summary of Plan Provisions sent by Mr. Kasper, Pullman & Comley. They had no further comments. Mrs. Whalen noted she had a few minor comments and will discuss Mr. Kasper. Pending that conversation, the Pension Committee will make a recommendation to the Board of Selectmen to approve the Amended and Restated Elected Officials Plan.

Fiducient Amended Fee Agreement re DC Practice Proposal 457/401 Plans – Mr. Eppers noted he received the Amendment to the Fiducient Investment Consulting Agreement reflecting the Scope of Services for the annual review of the 401(a) Plan held with ICMA and the 457 (b) Plan held with Voya. The additional fee for the review and oversight of these Plans is \$10,000. Mr. Eppers will contact Ms. Francis at Fiducient to discuss two points: Annual Review Start Date vs Consideration of an RFI for the two plans. The Committee will discuss further at October meeting.

Pension Trust Market Value: \$63.6 million, Plan Year to Date Return (PYD): 20.1%; OPEB \$4.4 million, PYD Return: 19.3.%
