MEMORIAL COMMISSION**

The Sandy Hook Permanent Memorial Commission held a special meeting on Thursday, January 11, 2018 in the Newtown High School Lecture Hall. Chairman Lyddy called the meeting to order at 7:35pm and began with a moment of silence.

The commission began evaluating and discussing designs. Some aspects of designs that were favorable, in addition to the prior meeting, were a center memorial, the reflection of names in a water feature, ponds not being modified and pathways over the ponds.

The following designs were unanimously voted on to eliminate from consideration:

The following designs were eliminated from consideration, but not unanimously:

SH 76: All agreed to eliminate except Bacon, who voted to keep for consideration.

The following designs were kept for consideration:

SH66: The commission unanimously voted to keep for consideration.
SH81: All agreed to keep for consideration except Bacon.
SH102: All agreed to keep for consideration except Bacon and Pinto.
SH108: The commission unanimously voted to keep for consideration.
