## 1. Planning and Zoning Alternate

Mr. Rosen opened the meeting by stating to the Commission there would not be a vote placed for the vacant Planning and Zoning Alternate position due to the vacancy being over 31 days.

The Commission spoke with Don Mitchell and asked him questions about his prior experience, conflicts and goals if he was elected as an Alternate to the Planning and Zoning Commission.
