**MINUTES**

**PRESENT:** Kadri Graffeo, Ed Randall, Robert Hawley

**CALL TO ORDER:** Mr. Hawley called the meeting to order at 6:20 pm.

**APPROVAL OF MINUTES:** Mr. Randall moved to accept the minutes of the March 18, 2024 Board of Assessment Appeals Regular Meeting. Seconded by Mr. Hawley. All in favor. Motion passes (3-0)

**NEW BUSINESS:**

Conduct hearings for Scheduled Appellants: (Room #1)

- **William Tarala III – Real Estate at 14 Edgelake Drive**  
Mr. Hawley began by administering the statutory oath. William Tarala III presented his case to appeal the assessment of the property listed above.  
Ms. Graffeo made a motion to approve the reduction in the assessed value from \$203,760 to \$64,460 and lower grade from C+ to E due to uninhabitable condition. Seconded by Mr. Hawley. All in favor. Motion passes (3-0).
- **Igor Krasnoperov – Real Estate at 26 Enclave Circle**  
Mr. Hawley began by administering the statutory oath. Igor Krasnoperov presented his case to appeal the assessment of the property listed above.  
Mr. Randall made a motion to approve the reduction in the assessed value from \$634,970 to \$588,000. Seconded by Mr. Hawley. All in favor. Motion passes (3-0).

Mr. Hawley began by administering the statutory oath. Evija & Rohan Mehra presented their case to appeal the assessment of the property listed above.  
Mr. Hawley made a motion to approve the reduction in the assessed value from \$721,800 to \$685,710. Seconded by Ms. Graffeo. All in favor. Motion passes (3-0).

Mr. Hawley began by administering the statutory oath. Greg & Paula Martiska presented their case to appeal the assessment of the property listed above.  
Mr. Randall made a motion to deny the appeal due to a previous reduction in the assessment value in 2022. Seconded by M. Motion passes 3-0).

Ms. Graffeo made a motion to approve the reduction in the assessed value from \$343,730 to \$321,562. Seconded by Mr. Randall. All in favor. Motion passes (3-0).
- **Co Trustees Paul & Sian Beddoe – Real Estate at 6 Twist Hill Road – Did not appear**
- **Robert L & Barbara Shohet – Real Estate at 51 Scudder Road**  
Mr. Hawley began by administering the statutory oath. Robert L Shohet presented his case to appeal the assessment of the property listed above.  
Mr. Hawley made a motion to approve the reduction in the assessed value from \$321,140 to \$315,000 based on the provided appraisal. Seconded by Mr. Hawley. All in favor. Motion passes (3-0).
- **Daniel Holmes – Personal Property at 2 Spring Street**  
Mr. Hawley began by administering the statutory oath. Daniel Holmes presented his case to appeal the assessment of the property listed above.  
Ms. Graffeo made a motion to deny the appeal based on insufficient proof to support the claim. Seconded by Mr. Randall. All in favor. Motion passes (3-0).
- **Caroline Nebo – Real Estate at 4 Mohawk Trail**  
Mr. Hawley began by administering the statutory oath. Caroline Nebo presented her case to appeal the assessment of the property listed above.  
Ms. Graffeo made a motion to approve the reduction in the assessed value from \$235,480 to \$150,900. Seconded by Mr. Hawley. All in favor. Motion passes (3-0).
- **Ando J Styler & Robert Shaw – Real Estate at 34 Great Ring Road**  
Mr. Hawley began by administering the statutory oath. Ando J Styler & Robert Shaw presented their case to appeal the assessment of the property listed above.  
Mr. Randall made a motion to approve the change in grade from B- to D. Seconded by Ms. Graffeo. All in favor. Motion passes (3-0).
- **Richard Lohrman – Real Estate at 2 Deer Hill Drive**  
Mr. Hawley began by administering the statutory oath. Richard Lohrman presented his case to appeal the assessment of the property listed above.  
Mr. Hawley made a motion to deny the appeal based on insufficient proof to support the claim. Seconded by Ms. Graffeo. All in favor. Motion passes (3-0).
- Mr. Hawley made a motion to approve the adjustments made by the assessor's office for 87 Personal Property adjustments. Seconded by Mr. Randall. All in favor. Motion passes (3-0).
