Special appropriation request for \$16,500 from the capital and non-recurring fund (undesignated funds) to participate in the UConn Internship and Professional Practice Program (IPP).

Through the IPP program Newtown will gain 585 hours of skilled support: Graduate interns work on special projects and program support for 15 hours a week for 39 weeks (August 23, 2021 – May 22, 2022). Graduate students have completed a year of rigorous graduate study and have developed significant skills in finance and budgeting, research design, statistical analysis, economics, policy analysis, human resources and other key areas of public and non-profit program management.


