- **Truck Committee:** Truck service started about a week and a half ago. Tim is concerned about from rust. He removed the molding off that goes over the C Channel and he will monitor it. Received 3 quotes for paint on Engine 1. 2 Quotes were

very close in price and one was a lot lower so Tim will reach out and look into it and see why such a difference. Will table for now but wants to have it addressed in the current budget.

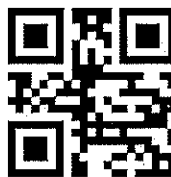

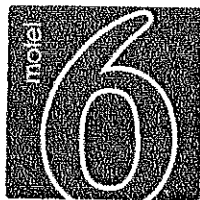
