PPE & Policy – NFPA Physicals are still being looked into, Dave was invited by the Town HR to take part in a zoom meeting with DOCS 1/24/23.

Dave has supplied HR with the parameters/ verbiage that Urgent Care has been using, so DOCS will use that to quote us a price.

Tim asked if AFS in Brookfield has been contacted and Dave said that he believes HR has contacted them several times and no return call as of yet. Dave will look further into it.

Radio/Hydrant It was brought up that NUSAR is interested in resuming dry hydrants inspections, providing a written report for each hydrant for a nominal fee of \$100.00 per. This would start in spring. NUSAR has previously provided this service in years past, but it has not taken place in several (6-7) years. It's been talked about that the dry hydrants need and should be inspected and should be done on a schedule. There are approximately 40 dry hydrants in town.

Radio Committee Sub Committee-

Mark DeWolfe brought some portable radio's to the meeting for the Chiefs to look and determine if the programing is good once that is approved we will get all the equipment and get these installed as quick as possible. Radio sites- Dinglebrook is about 85% complete.

He also reported that all pagers have been delivered; portable radios will be delivered as well. Once approved, all pagers and portables will have the analog zone removed. The projected date for the project to be completed is June 1, 2023 with a possible punch list.

Truck- Tim reported that the parts for T-9 and 229 are still on back order. Sandy Hooks Ladder truck- ladder training this weekend- The truck is going back to Greenwood for unfitting. It should be in-service mid-February.

Budget-. Tim, Pat and Ron went to the BOS Budget meeting. Tim reported that they cut the Fire Admin position and the Fire Marshals vehicle and that was really all we lost. The BOS did some rearranging in fund accounts.
