Minutes of the Special Meeting of the Borough of Newtown Zoning Commission on Wednesday, July 25, 2017 at the Borough Office, 45 Main Street, Newtown, Connecticut. Mr. Nelson called the meeting to order.

Lexington Garden Project:

Discussion took place regarding 30 Church Hill Road. The zoning commission had reviewed revised drawings, dated June 27<sup>th</sup>, for the building on the previous July 12<sup>th</sup> meeting. Tonight's discussion was to determine approval of the revised drawings and if the changes were considered substantial. The new drawings show additional trim on the building and the building no longer being painted.

A motion was made by Mr. Francis to approve the revised drawings of 30 Church Hill Road.

The motion was seconded by Mr. Guman and was unanimously approved.

A motion was made by Mr. Francis stating the changes were non-substantial.

The motion was seconded by Ms. Mitchell and was unanimously approved.

Borough Landmark Building and Edmond Town Hall:

Chairman Doug Nelson stated a draft of proposed uses for the Borough Landmark Building and the Edmond Town Hall will be ready to be submitted to the Zoning Commission at the August 9<sup>th</sup> meeting. The Zoning Commission will then elect to send the draft to Planning. Whether Planning approves/disapproves the draft, the draft will

then go to a public hearing. The draft speaks of general uses for the Borough Landmark Building and the special exceptions will speak to the proposed uses for Edmond Town Hall.

**EXECUTIVE SESSION:** Secretary Brid Craddock moved to enter executive session for discussion on next Zoning Enforcement Officer. Ms. Claudia Mitchell seconded. Executive Session was entered at 7:32pm and returned to regular session at 8:15pm with the following motion:

## 48 Main Street:

It was determined by the commission that the repairs did not fall under the requirement to submit a village district application.
