THESE MINUTES ARE SUBJECT OT THE APPROVAL OF THE COMMISSION ON AGING.

The Commission On Aging held a regular meeting on Monday, November 19, 2018 at 5:00 pm at the Newtown Municipal Center, Council Chambers, 3 Primrose Street, Newtown, CT.

CALL TO ORDER: Ms. Wiedemann called the meeting to order at 5:00 pm.

PRESENT: Anna Wiedemann, Barbara Bloom, LeReine Frampton, George Guidera, Ruby Ryles (5:03), Curt Symes. Alternates: Larry Passaro, Claire Theune, Maureen Will.

ABSENT: John Boccuzzi, Anne Rothstein, Mae Schmidle.

ALSO PRESENT: First Selectman Dan Rosenthal, Director of Social Services Ann LoBosco, Officer Maryhelen McCarthy, Selectman Maureen Crick Owen, Cyrenius H. Booth Library Assistant Director Beryl Harrison, 5 members of the public.

PUBLIC COMMENTS:

Louise Zierzow, Sandy Hook – A few months ago, Ms. Zierzow said she inquired about unsafe parking lot and sidewalk conditions at the Senior Center, conditions still exist and have not been addressed. Ms. Zierzow was told this would be addressed. She shared photos of sidewalk and other areas showing unsafe, poor conditions, potholes, and asked what will be done, expressing a sense of urgency. Mr. Rosenthal offered to speak to Public Works in the morning. Ms. Zierzow also asked about the transportation meeting, Mr. Rosenthal said that he had inquired with WestCOG and they will hold another meeting in Newtown and better advertise it. *Gary Macrae, Newtown* – Mr. Macrae offered his help to research programs similar Village to Village Network.

REPORTS

CHAIR REPORT: Ms. Wiedemann shared the November 2018 COA Chair Report. (ATTACHMENT) Ms. Wiedemann recognized Officer McCarthy, Ms. Will, and Ms. Schmidle for recent awards. Ms. Wiedemann reached out to The Bee and Voices regarding the

programming subcommittee information. Ms. Wiedemann said that The Regency requested 65 copies of the Resource Guide, when printing also consider additional quantities for other similar senior residences. Ms. Wiedemann asked if COA could share thoughts or concerns about Senior Center reports so Ms. Place can help address and get answers to any questions ahead of scheduled COA meetings.

VICE CHAIR REPORT: Mr. Guidera said there is an upcoming program subcommittee meeting on December 14, he encouraged attendance at the meeting. Mr. Guidera requested a comprehensive plan from management that includes robust attendance projections with strong programming for the new senior center. Mr. Symes shared a 3-track programming plan and offered to help identify needs.

DIRECTOR OF SENIOR SERVICES: In Ms. Place's absence, Ms. Wiedemann asked for questions on reports provided by the senior center. (ATTACHMENT) Mr. Passaro expressed concern over some of the attendance statistics and to progress on ways to boost attendance. Clear attendance details are necessary for grant applications and insurance purposes. Mr. Symes asked for clarity on attendance by zip codes. Mr. Guidera noted the need for solid leadership at the senior center and the importance of attendance at COA meetings. Ms. Ryles inquired about staffing levels at the senior center. Mr. Symes mentioned the importance of volunteer support. Mr. Rosenthal said that budgeting for staffing at the new senior center is under discussion.

DIRECTOR OF SOCIAL SERVICES: Ms. LoBosco distributed the Director of Social Services Report. (ATTACHED)

GRANTS COMMITTEE: Ms. Bloom said she received an email about arts grants and will also look into for grants for transportation.

NOMINATING COMMITTEE: Ms. Frampton said that the current officers wanted to stay, Ms. Wiedemann – Chair, Mr. Guidera – Vice Chair, Ms. Schmidle – Parliamentarian, Ms. Rothstein – Treasurer. Vote will be at next month's meeting. Offices take effect in January 2019.

Rebranding of the senior center – Ms. Wiedemann proposed meeting for further discussion on December 14 at 3:00 prior to the subcommittee meeting.

LPI – Ms. Wiedemann said that efforts continue with Constant Contact.

Village to Village – Mr. Macrae discussed the concept that cities and towns have adopted to enhance the quality of life for senior who choose to age at home, remain active in the community. Village to Village Network and Beacon Hill Village are examples of organizations that help seniors age in place. Beacon Hill Village, <u>www.beaconhillvillage.org</u>, a member-driven organization for Boston residents 50 and over, provides programs and services so members can lead vibrant, active and healthy lives, while living in their own homes and neighborhoods. Benefits include access to discounted providers who can help seniors manage their household, stay active and healthy, and serve needs. Social and cultural programs are always changing to support member interests. For further insight into changing demographics of the senior community, Mr. Macrae suggested reading the book, *The Longevity Economy*.

COMMISSION ON AGING

Should towns be interested in these types of organizations, towns are not responsible for recommending, but an organization like Friends of Newtown can reach out and make recommendations.

Renter's Rebate for 2017 – 78 applications

- Distributed Thanksgiving Baskets to 73 families; 42 are Senior/Disabled. Holiday Baskets will be distributed on December 15th. Received an abundance of extra items for our food pantry.
- Salvation Army will be bell ringing on December 7, 8, 14, and 15.
- Attended Housing Law Workshop presented by CT Legal Services. Topics included tenant-landlord relationship, subsidized housing, evictions, and rights of disabled tenants.
- Attended Elder Law Lunch & Learn at the Senior Center which focused on Medicaid/Title 19. Was very informative!!
- Fuel assistance began deliveries on November 14th. The program is running much smoother this year because of reorganizing at CAAWC.
