The Commission on Aging held a regular meeting on Monday, July 17, 2017 at the Senior Center, 14 Riverside Road, Sandy Hook, CT.

Call to order: 5:01 pm.

PRESENT: Anna Wiedemann, George Guidera, Mae Schmidle, Anne Rothstein, Ruby Ryles, Barbara Bloom, Curt Symes, John Boccuzzi, LeReine Frampton, Claire Theune, Larry Passaro.

ALSO PRESENT: Marilyn Place, Ann LoBosco, Officer Maryhelen McCarthy, Communications Director Newtown Emergency Communications Center Maureen Will, Dan Rosenthal, 1 member of the public, 1 press.

ANOUNCEMENTS: Ms. Wiedemann welcomed Mr. Passaro as the newest member to the Commission On Aging.

PUBLIC PARTICIPATION: None.

MINUTES: Mr. Guidera moved to approve the minutes of the June 19, 2017 meeting. Second by Ms. Rothstein and unanimously approved. All in favor.

REPORTS:

DIRECTOR OF SENIOR SERVICES: Ms. Place distributed the monthly report and asked for questions. ATTACHMENT A. Ms. Place reviewed the new website, the launch, presentation at the Baptist Church, July 27 at 1:00. Ms. Place discussed a new Lunch and Learn with Jennifer Crane, Newtown Center for Wellness on August 25, need to pre-register. Shades of Purple Triad discussed. Ms. Place brought forth the discussion of updating the magnets and need to purchase new ones. Regarding printing, Ms. Schmidle suggested that the name be on it. One question brought up is how to best inform seniors and family members of best placement of forms in the home, with caregivers, needed for emergency care such as no CPR form, DNR form so medical personnel can be aware of intentions. Mr. Guidera pointed out challenges of following intentions even when person is in the hospital, it is important to keep extra copies of documents at hand. Ms. Bloom moved to approve the purchase of magnets of a quantity of 501 at approximately \$1.39 each from the gift account that includes Commission On Aging logo identification name and phone number. Second by Mr. Guidera and unanimously approved. All in favor.

Ms. Place discussed plans for the annual picnic scheduled for August 21 and requested funding at \$3.00 each, Hart transit is free. Taking the van for the lift. **Ms. Bloom moved to approve \$429.00 for the picnic.** Second by Mr. Boccuzzi and unanimously approved, All in favor.

DIRECTOR OF SOCIAL SERVICES: Ms. LoBosco shared the Director of Social Service Report in a new format. ATTACHMENT B. She reviewed operation fuel program and state funding cuts related to the program as well as other programs, such as farmer's market vouchers. Mr. Symes discussed ways to give out portions to keep within budget constraints, Ms.

Frampton suggested to put information in The Bee, Mr. Boccuzzi asked about certain times of the year that power can't be shut down. Operation fuel is \$500.

TREASURER'S REPORT: Ms. Rothstein reviewed the Treasurer's Report. ATTACHMENT C. Ms. Bloom moved to file for audit. Second by Ms. Rothstein and unanimously approved. All in favor.

CHAIR/VICE CHAIR: Ms. Wiedemann and Mr. Guidera shared the Chair Report, ATTACHMENT D. Ms. Wiedemann said she is not aware of any committee meetings. Discussion moved to the Senior Center Community Center.

OLD BUSINESS:

Senior Center Advisory - Mr. Guidera spoke about meetings of the Community Center Advisory Committee and meetings related to the design of the new Senior Center and Community Center, Fairfield Hills Authority, meeting with Caldwell Walsh last Friday, no meeting this coming Friday, but will meet on the 28th. P & Z approved design, Fairfield Hills Authority approved. Concerns expressed at meetings included layout of the building, exterior, parking areas. Mr. Guidera said he expressed concern of bidding process and was reassured by architects and Caldwell and Walsh. Donated goods and services discussed. Mr. Passaro said questions were raised about the budget. Specific to 3 budgets, GE money, money approved for the community center, and one approved for the senior center. Ms. Frampton said that Caldwell Wash has the estimators, Mr. Symes said to have confidence in the process. Accountability discussed. ATTACHMENT E.

Grants: Barbara Bloom, John Boccuzzi & Anne Rothstein – discussed the changes in the charter, grant application process, check receipt process, what the process is and how to best follow it. Ms. Rothstein suggested to speak together with the people in the town that deal with grants, along with Cristal Preszler.

Review and updates SC booklet: Claire Theune & Anne Rothstein – Ms. Theune said that they reviewed materials from other senior centers, discussed directory of pertinent telephone numbers and email addresses. Funding and costs discussed, as well as cover design and layout. Maureen Will offered to reach out to her contact at Staples. Three bids required for printing. In the past, 500 were printed. Cost of .71 discussed. Booklet to have comprehensive information, include resources. Mr. Passaro asked for information on local discounts, as in the Ridgefield booklet. Ms. Theune discussed target date of January 2018 for distribution.

Elderly Financial Abuse: COA members: George Guidera, Marilyn Place, Ann LoBosco. Advisory: Maryhelen McCarthy & Maureen Will - no meeting.

Wellness Series: Anna Wiedemann & John Boccuzzi – no meeting. VNA 100 year anniversary coming up. Mr. Boccuzzi referred to aging master program, managed by Ms. Ryles - said the aging master program is a team program that deals with every aspect of aging, starts with exercise, sleep disorders, financial fitness, advance planning, social relationships for example, a 10 week program. Mr. Boccuzzi said he will check if Western Connecticut would be interested.

TRIAD: COA members: Marilyn Place, Anna Wiedemann, John Boccuzzi. Advisory: Maryhelen McCarthy Ms. Place said the event has been a year in the making, many speakers come together, September 29 from 1-4, TRIAD Shades of Purple event.

Communications: Ms. Ryles discussed the brochure, need a photo next month, with new member, come 10 minutes early for photo.

NEW BUSINESS: Ms. Schmidle discussed the Southington new senior center, grant funded. She hopes the COA will have some input on interior aspects of new senior center. She expressed interest in making the new senior center a more visible area, consider promotional

materials to promote the center, also have a presence in the Labor Day parade. Ms. Schmidle made a motion for sign to be made up to be placed on the car for the parade, use of \$200 in funds and if more Ms. Schmidle will procure the extra funds, executive committee to come up with recommendations for the sign, present plan at next month's meeting to make a decision. Second by Ms. Frampton and unanimously approved. All in favor.

Mr. Passaro said that he has visited senior centers in all of the towns around Newtown, he asked what would they have been done differently, he suggested that if COA have the time, arrange to have a tour of local senior centers. Mr. Passaro asked everyone to think about renaming the senior center, consider removing senior out of senior center, give it some thought, come up with something creative to share.

Mr. Symes brought up charter revision verbiage, not on the website, how to get updates, on website, each department is responsible for updating website. Ms. Will offered to look into it.

PUBLIC PARTICIPATION: none.

ADJOURNMENT: There being no further business, <u>Ms. Frampton made a motion to adjourn</u> the meeting at 6:35 pm, Second by Ms. Bloom and unanimously approved. All in favor.

WHAT IS TRIAD?

Triad is a community policing initiative between seniors, law enforcement and service providers to increase safety through education and crime prevention. Its goals are:

- To reduce criminal activity that targets older Americans
- To alleviate seniors' fear of victimization, build confidence and improve the quality of life
- To enhance delivery of law enforcement services to older persons
- WHAT DO TRIADS DO?
- Empower give seniors direction.
- **Educate** gather information on criminal activity, and sponsor crime prevention workshops and other programs.
- Reach Out reduce fear and increase peace of mind for seniors who live alone, through home visits by law enforcement officers.
- More Links provide a forum to discuss crime-related needs and concerns of seniors, identify problem areas and develop and implement community-wide solutions.

WHAT CAN RESULT?

Seniors can gain from regular contact with police officers, direct involvement in crime prevention strategies and awareness of available services.

Law enforcement gains more contact with seniors, better awareness of seniors' crime-related fears, more understanding of the human service field, and increased respect and understanding for the department by members of the community.

Human service providers gain from improved distribution of services, more cooperation with other providers, and better understanding of law enforcement and the challenges it faces.

Program Statistics

Energy Assistance Applications (245 applications – 160 Senior/Disabled = 65%)
Food Pantry (45 individuals/families visit weekly – 30 Senior/Disabled = 66%)
Operation Fuel (Spring program) – (16 applications - \$6,997.88 total –11 Sr/Disabled = 68%)
Operation Fuel (Summer program) – (1 application to date – 1 Senior/Disabled)
Salvation Army – (30 applications to date - \$9,552.92 total – 12 Senior/Disabled = 40%)
Goodwill gift cards – 4 distributed
Renter's Rebate – Program started on April 3rd (55 applications to date).

The Operation Fuel Program started up again on July 5th for the summer which helps with electric bills. However, due to the fact that our governor and state legislature are still negotiating a budget, the funding is uncertain. The funds allocated to us for the summer program are limited. Some towns are opting to discontinue taking applications. However, clients can still be enrolled in Newstart or code for winter protection as long as they are within the 60% median income limit.

The Farmer Market voucher program administered through the state has been put on hold as well due to our lack of budget. (The program allows low income seniors 60 years and old to receive six \$3 coupons for use at Farmers Markets.)

Met with a reporter from The Newtown Bee who is writing an article about the special challenges that senior citizens face when living alone. The article will be an in-depth look into the everyday struggles seniors face like coping with housing, care of the home, long-term care for their health, transportation, ways to socialize, etc. The article is expected to come out in the next week or two.

Received a referral from Meals on Wheels regarding a disabled women whose income is very limited in relation to her cost of living. She is looking for help with house cleaning once or twice a week. I will be meeting with her this week to discuss her options and possibly applying for Medicaid for her.
