COMMISSION ON AGING REGULAR MEETING

THESE MINUTES ARE SUBJECT TO THE APPROVAL BY THE COMMISSION ON AGING.

The Commission on Aging held a regular on Monday, August 21, 2017 at the Senior Center, 14 Riverside Road, Sandy Hook, CT.

Call to order: Ms. Wiedemann called the meeting to order at 5:06 pm.

PRESENT: Anna Wiedemann, George Guidera, Mae Schmidle, Anne Rothstein, Ruby Ryles, Barbara Bloom, Curt Symes, John Boccuzzi, LeReine Frampton, Claire Theune, Larry Passaro, Maureen Will.

ALSO PRESENT: Marilyn Place, Ann LoBosco, Officer Maryhelen McCarthy, Jules A. Martin, Jennifer Crane – Director Newtown Center for Support and Wellness, Dan Rosenthal, Selectman Will Rodgers, Cathy Sullivan, Cindy Dessel, Marie McLenithan, 2 members of the public.

PUBLIC PARTICIPATION: None.

MINUTES: Mr. Boccuzzi moved to approve the minutes of the July 17, 2017 meeting. Second by Ms. Frampton and unanimously approved. All in favor.

Ms. Wiedemann introduced Jennifer Crane, Director of the Newtown Center for Support and Wellness. Ms. Crane provided an overview of the center, the role of the center, a referral service, that helps to connect members of the community with wellness resources. (ATTACHMENT A) The center was started in March 2016, in response to those impacted as well as the whole community since 12/14. Ms. Crane said that the center works closely with Anne LoBosco, on a variety of issues including assistance with food, fuel, for example. The center also works closely with the police department, social work and case management, crisis management, preventative situations. Looking at the whole wellness of the community, Ms. Crane asked what the committee is looking for in relation to services in the community. Ms. Wiedemann said the VNA is celebrating the 100th anniversary, would they be able to coordinate with Ms. Crane and the center and Ms. Crane replied yes. Ms. Crane asked what the center can do for the community, addressing issues in the Newtown population. Ms. Wiedemann referred to depression and loneliness, concern of looking out for someone that lives alone. Ms. Frampton said as many seniors downsize, transportation is an issue. Ms. Place added that loss is of a concern. Mr. Boccuzzi said concern of mental health, socialization, Ms. Crane said this was a vision a year ago as a social work program, they deal with a variety of age ranges right now from of 5 – 89. Ms. Crane is starting to see a lot of hoarding issues/concerns.

Mr. Symes said that stress management is an issue, effective stress management can help with preventing depression, he cited Dr. Joyce Saltman, presentation with humor as a solution to stress management. Ms. Will said to consider the new independent silent senior, not everyone embraces being a senior, there are those who are silent for various reasons. Ms. Ryles said she is in the process of reading a survey of those that cannot afford services based on their income. Ms. Crane spoke to the need to get out to people that need us. Mr. Rosenthal said that he wants to make sure the center serves the whole community. Officer McCarthy said the center is a great service. Ms. Crane will be back on Friday at 11:45. She will be part of the Triad.

Ms. Wiedemann welcomed new member, Maureen Will, to the Commission On Aging.

REPORTS:

DIRECTOR OF SENIOR SERVICES: Ms. Place distributed the monthly report.

(ATTACHMENT B) Ms. Place requested money for refreshments for purple triad up to \$100.

Mr. Boccuzzi moved to approve up to \$100 for refreshments for Triad purple event.

Second by Ms. Frampton and unanimously approved. All in favor.

Ms. Place spoke to upcoming events, art show.

DIRECTOR OF SOCIAL SERVICES: Ms. LoBosco distributed the Director of Social Services report, highlighting the recent donation from Knights of Columbus, backpack program. **(ATTACHMENT C)**

TREASURER'S REPORT: Ms. Rothstein spoke to the financial report. (ATTACHMENT D) Mr. Passaro inquired about the list of the purchases, from BJ's and BigY. Ms. Place said that those are for refreshments for the Senior Center. Ms. Frampton moved to file for audit. Second by Mr. Boccuzzi and unanimously approved. All in favor.

CHAIR/VICE CHAIR: Ms. Wiedemann distributed the chair report (ATTACHMENT E) welcoming Ms. Will and announcing the round table discussion on September 18.

OLD BUSINESS: Ms.Theune reported on the SC booklet, she provided three quotes. Three additional vendors recommended. While she pursues additional quotes, Ms. Theune said to think more about the cover, maybe a drawing, consider something different. Mr. Symes recommended a rendering of the new senior center.

COMMUNICATIONS: Ms. Ryles spoke to the brochure, cultural arts. Ms. Wiedemann said to put together locations for pick up and delivery. Ms. Schmidle spoke to the parade, all set and ready to go, working on a banner.

NEW BUSINESS:

PUBLIC PARTICIPATION: Mr. Rodgers introduced himself and commented to be proactive about the selection of new members to the COA committee, he explained the BOS needs to post notice of available positions. Ms. Wiedemann asked if there is a way to work better together, if people want to apply, never told of people interviewed. There is a miscommunication that we have to work together better.

Ms. McLenithan said that it was difficult to hear people during tonight's meeting. Ms. Wiedemann said they will rearrange seating and move everyone forward for the next meeting.

ADJOURNMENT: There being no further business, <u>Ms. Frampton made a motion to adjourn the meeting at 5:55 pm.</u> Second by Mr. Boccuzzi and unanimously approved. All in favor.

- You will receive the referral information so that you can call the provider directly.
- 5. A staff member from the center will follow up until you are connected with an appropriate provider

UPDATE: TRIAD ...below is a full description of TRIAD for those not familiar. In 2003 Newtown became the 11th town in the state to partake in a collaboration with local law enforcement to create a safer community.

WHAT IS TRIAD?

Triad is a community policing initiative between seniors, law enforcement and service providers to increase safety through education and crime prevention. Its goals are:

- To reduce criminal activity that targets older Americans
- To alleviate seniors' fear of victimization, build confidence and improve the quality of life
- To enhance delivery of law enforcement services to older persons
- WHAT DO TRIADS DO?
- Empower give seniors direction.
- Educate gather information on criminal activity, and sponsor crime prevention workshops and other programs.
- Reach Out reduce fear and increase peace of mind for seniors who live alone, through home visits by law enforcement officers.
- More Links provide a forum to discuss crime-related needs and concerns of seniors, identify problem areas and develop and implement community-wide solutions.

WHAT CAN RESULT?

Seniors can gain from regular contact with police officers, direct involvement in crime prevention strategies and awareness of available services.

Law enforcement gains more contact with seniors, better awareness of seniors' crime-related fears, more understanding of the human service field, and increased respect and understanding for the department by members of the community.

Human service providers gain from improved distribution of services, more cooperation with other providers, and better understanding of law enforcement and the challenges it faces.

Also note in all State and National Aging reports besides the CASCP (CT Assoc. of Senior Center Personnel) all exercise classes (depending on what type of classes) are anywhere from 15 to 20 per class. Some are up to 30 only.... per teacher. This is statewide practice. So, when we have larger size rooms for exercise in the new SC it will make a huge impact of not being claustrophobic as we have now in these small rooms.





Program Statistics

Energy Assistance Applications (245 applications – 160 Senior/Disabled = 65%)
Food Pantry (45 individuals/families visit weekly – 30 Senior/Disabled = 66%)
Operation Fuel (Spring program) – (16 applications - \$6,997.88 total –11 Sr/Disabled = 68%)
Operation Fuel (Summer program) – (7 application to date – 3 Senior/Disabled)
Salvation Army – (30 applications to date - \$9,552.92 total – 12 Senior/Disabled = 40%)
Goodwill gift cards – 4 distributed
Renter's Rebate – Program started on April 3rd (63 applications to date).

Donations from the Victory Garden to the pantry have been coming in nicely. The pantry is getting low on some items such as cereal, peanut butter, tuna, pasta sauce, rice, cleaning supplies, and personal products. An email blast was sent out to Town & BOE employees last week asking for help. We have already received some monetary donations as well as items. We expect donations to increase as we get closer to the holidays.

The Backpack Program has begun and we are anticipating 70 backpacks being distributed this year (some of which are for children being raised by grandparents). Volunteers from W.I.N. and The Mom's Club have been assisting with providing the supplies as well as helping to assemble them.

Attended the AgeWellCT kickoff at the Senior Center. The website looks great and we have been referring a number of people to take the time to navigate through and see what information is available.

Applications for the Energy Assistance Program will be accepted starting September 25th. Fuel deliveries will begin on November 15th. The Basic Benefit Levels are a bit higher than last year; however, depending upon state funding the numbers could be adjusted.
