Directors Report

Construction Update-

Temporary CO is expected by July 1st.

During an early value engineering process, driveway drainage was removed and replaced with a landscaping plan that outlined specific trees and plants to soak up ground water before it enters cooling-catch basins as well as to cover the run off from the back hill. During the next value engineering session in late-2018, landscaping was completely removed. Mr Ariniello was advised that this VE'd landscaping plan is an integral part of the total construction plan and must be completed in order to get a CO. He is looking for donations and volunteers to get this part done. The original contractor's bid price was about \$300,000 dollars for plantings and labor. Mr Ariniello worked with Mr Sibley (Town Land Use) who agreed to issue a temporary CO if certain sections are completed by early July 2019. The remainder must be completed before winter 2019. Mr Ariniello ordered 260 trees to be delivered June 24th which will cover the temporary CO requirements. They will all have to be placed and planted next week to obtain the temporary CO on time. He has asked for volunteers to assist with this process.

The remaining trees/plants/shrubs will need to be planted within a few months. This also includes the back hill which is from the EOC building down to the Center to control run off. Mr Ariniello has spoken with the local pollinators group who expressed interest in planting a pollination garden in the back. Mr Ariniello

requested members submit suggestions of places to obtain donations or labor to help with the rest of the required plantings. Mr Tousignant volunteered to assist Mr Ariniello with this project.

Paving

Paving was delayed due to the rain. Hopefully finished this week so planting can be done next week.

Phones and internet should be ready by 7/15.
