The Fairfield Hills Authority held a Meeting on August 27, 2018 in Council Chambers at the Municipal Center, 3 Primrose Street, Newtown CT 06470

These minutes are subject to the approval of the FHA at their next meeting.

The meeting was called to order at 7:11 pm.

Public Participation: none

### Minutes:

Acceptance of the minutes was tabled until next meeting due to lack of quorum.

### Parks & Rec - Pickball presentation:

Amy Mangold, Director of Parks & Rec, presented Authority members the Parks & Rec plan to add pickleball courts to the Fairfield Hills campus. The Parks & Rec CIP originally had the line items for these courts under 2021-2022. The project has now been moved up to 2019-2020. She clarified that the project is not definitely funded, and that the request currently is in the CIP process. Parks & Rec advanced the request by 2 years due to the tremendous outpour from residents in town.

Amy then informed members that on March 23rd of 2015, Parks & Rec presented an update to the Parks & Rec master plan for the Fairfield Hills campus, and distributed information for members to review outside of the meeting. She referred to Figures ES 6 – Fairfield Hills Master Plan – Playing Fields dated May 2003, which showed an overview of the campus with recommended locations for athletic fields. Amy then directed members to refer to the Fairfield Hills – Master Plan – Site Plan Rendering dated August, 26, 2013 which was created at the request of George Benson to provide further detail. Amy pointed out that this map had a recommendation for a recreation center which included Pickleball courts showing that Pickleball courts have been a consideration since 2013. Finally Amy referred members to the Fairfield Hills Master Plan – Site Plan Rendering revised as of August 2018. This map shows the currently proposed location for the Pickleball courts in the area of the Emergency Operations Center, Glander fields and the Community & Senior Centers. Members asked for details regarding the number of courts. Amy explained that 4 pickleball courts equates to the size of 1 tennis court, and that the cost would be between \$55,000 - \$60,000 per courts. She further detailed that the courts would be made up of post tension concrete which is the same construction as the tennis courts at the town parks. The cost includes adequate fencing and greenery. It will cost an additional \$140,000 for lights. The

infrastructure for the lights would be installed at the time the Pickleball courts are built, but the actually lighting would be installed at a later time. Since there are many new members on the Authority, Amy informed Chairman, Ross Carley that she and Ed Marks (Chairman of the Parks & Recreation Commission) would like to attend another FHA meeting to present the Parks & Rec Master Plan for the campus. The group had a brief discussion regarding the need to ensure there is sufficient parking. Ross then thanked Amy for her time.

### Chairman's Report:

### Brewery:

Ross Carley updated members that the brewery is moving along and that minor details are being finalized. The base of the lease approved by the FHA remains with only details being modified as necessary. Renata again expressed concerns with distribution requiring large trucks on the campus. Ross explained that this was not a concern and highlighted that the brewery owners are Newtown residents who want to do well by the town.

Ross added that he has also met with people who have expressed interests in various areas of the campus, and that all interested parties are first directed to Christal Preszler (Deputy Director of Planning for Economic and Community Development) and George Benson (Directory of Planning) before a proposal is brought forward to the FHA.

### Cupolas:

Ross reminded members that there are 3 cupolas on the campus that can be repurposed. Many people have expressed interest in making purchasing these cupolas for either commercial or private use, however he has concerns with selling these cupolas with loose lead paint. Brook recommended that the cupolas be reused on the campus as part of a garden landscape. The group then discussed options. Ross informed members that there is no immediate need to make any decision.

### Budget:

The group then discussed the reduction in the FHA budget and current planned spending.

### Member Update:

Mike Holmes asked for a status on the proposed tennis facility. Ross said that discussions are ongoing and the current concept would require the removal of Cochran Hall.

Kim added that the committee is also working on membership packages and policies & procedures.



# Figure ES 6 Fairfield Hills Master Plan – Playing Fields


