NEWTOWN HEALTH DISTRICT JOB DESCRIPTION ASSISTANT SANITARIAN

GENERAL STATEMENT OF DUTIES: Performs duties related to the control and improvement of environmental health.

SUPERVISION RECEIVED: Works under the supervision of the Director of Health. May work under the general supervision of employee(s) of higher grade.

EXAMPLES OF DUTIES:

- 1. Investigates complaints involving public health hazards and initiates appropriate abatement procedures.
- 2. Inspection of food service establishments for compliance to state and local regulations.
- 3. Review and approval of proposed food service facilities.
- 4. Review and approval of proposed well locations for compliance to state and local regulations.
- 5. Inspection of schools, day care centers, housing, swimming and bathing areas, and other public facilities.
- 6. Collection of water samples for potability and other analysis.
- 7. Investigates suspect sewage disposal system failures and initiates appropriate abatement procedures.
- 8. Inspect all phases of subsurface sewage disposal installations for compliance to state and local codes.
- 9. Conduct site investigations to determine suitability for subsurface sewage disposal systems including but not limited to percolation test and deep hole tests.
- 10. Review and approval of proposed engineered and non-engineered subsurface sewage disposal system designs.
- 11. Performs other related assignments as required.

EDUCATION, EXPERIENCE and TRAINING:

Four year college degree in Biological and/or related Environmental studies. Certification training for subsurface waste disposal system and be certified to inspect food service facilities or obtain certificate within 6 months. At least two (2) years as trainee Sanitarian or related position.

KNOWLEDGE, SKILLS, AND ABILITY:

Knowledge of principles and practices of environmental health. Knowledge of the laws, rules, and regulations pertaining to municipal environmental health and sanitation control.
