#### **PUBLIC HEARING**

**Application #18-26 by Hawleyville Properties, LLC, Matthew D'Amico,** property located at 90 Mt. Pleasant Road, 10 Hawleyville Road and 1 Sedor Lane, for construction of a medical office building, three warehouses and associated grading.

### PENDING APPLICATION

**Application #18-25 by Planters Choice LLC,** property located at 140, 153, 155 Huntingtown Road and 23 Meadowbrook Road, for wetland mitigation and stormwater improvements to correct an Inland Wetland Violation.

Mr. Ferris moved to approve **Application #18-25 by Planters Choice LLC**, property located at 140, 153, 155 Huntingtown Road and 23 Meadowbrook Road, for wetland mitigation and stormwater improvements to correct an Inland Wetland Violation with standard conditions A, B, C, D, E, F, L, O & P and the following additional conditions:

- Water quality sampling:
  - o Bi-annual stormwater quality sampling to take place in the Spring and Fall every year
  - Sampling shall be performed by a third party environmental professional and results shall be submitted to the Land Use Agency
  - Sampling parameters to be determined by Land Use Staff including but not limited to nitrogen, phosphorous, chloride, E.coli, ammonia, turbidity, dissolved oxygen and pesticides.

- Samples shall be taken no earlier than thirty minutes after commencement of a significant rain event over 1 inch but not more than 2 hours after commencement of rain event.
- The three locations to be sampled are identified on the plans.
- Plantings shall be monitored for two growing seasons to ensure their survival and be replaced if necessary.
- A wetland scientist will re-inspect wetland areas with sediment accumulation specifically wetland areas JMM C-11 – C-30 and JMM AA-1 – AA-6 as mitigation work progresses. Wetland areas with over 4 inches of sediment shall be removed by hand.
- All inorganic debris such as plastic that has been deposited in the wetlands and adjacent areas shall have ongoing removal and monitoring.
- All stormwater treatment basins to be inspected and verified by licensed engineer upon completion and submit report to the Land Use Agency

The approved plans are: Mitigation Plan for 140, 153 and 155 Huntingtown Road and 23 Meadowbrook Road, prepared by A2 Land Consulting, LLC, prepared for Newman Holdings, LLC. Dated Revised November 9, 2018, December 7, 2018, January 7, 2019 and all supporting documents. Mr. McCabe seconded. All in favor.
