Pending Application

Application IW #20-20 by Donna and Roger Ball, property located at 20 Saw Mill Road for pond dredging.

Ms. Salling began the meeting by asking the Commission if they had any additional questions or needed clarification before taking a vote.

Mr. Ferris requested an overview of the new information. Mr. Hnatuk presented the proposed maps and pictures. Mr. Hnatuk stated there are no wetlands in the newly proposed dumping area.

The Commission was satisfied with the overview and had no additional questions.

Mr. McCabe moved to approved Application IW #20-20 with standard conditions A, B, C, D, E, F, O, & P.

Mr. Ferris seconded. All in favor. **Application IW #20-20 by Donna and Roger Ball**, property located at 20 Saw Mill Road for pond dredging was approved.
