CALL TO ORDER: K. Alexander called the meeting to order with the Pledge of Allegiance at 7:33pm.

J. Bloom moved to add 24/25 budget discussion to the agenda. J. Zachos seconded, all in favor.

VOTER COMMENT: None

MINUTES: J. Bloom moved to approve the minutes of the 2/7/24 regular meeting and 2/26/24 special meeting, H. Dean seconded. T. Long was concerned that the action sent to the Ordinance committee was not included in the 2/7/24 minutes. J. Bloom moved to amend the motion to approve only the 2/26/24 special meeting minutes, H. Dean seconded, all in favor.

COMMUNICATIONS: See Attached.

COMMITTEE REPORTS: J. Bloom reported that the Ordinance Committee had their first meeting this evening. They are charged to determine if the Recycling Adhoc Committee should be turned into a permanent meeting. They are going to research this and have the First Selectman at the next meeting on 3/20/24.

FIRST SELECTMAN'S REPORT: First Selectman Capeci reported that they have found a Finance Director replacement. She is currently the financial analyst for Saco ME and will start with the Town on April 1. The BOF passed the budget and is now with the LC. There is no update on the walking bridge in Sandy Hook Center.

NEW BUSINESS

Fill vacancy on Legislative Council District 1 - L. Miller moved to nominate Jill Soderholm. Voting limited to Democrats. All in favor (Gardner, Miller, Alexander, Bloom, Paradis, Dean).

Grant Acceptance SS4A (Safe Streets and Roads for All) – J. Bloom moved to approve the Safe Streets and Roads for All grant (att). H. Dean seconded. Fred Hurley explained they are looking for various ways to reduce pedestrian and motorist serious injuries and fatalities. This action plan is the start, then if we need additional development or planning funds and the final piece would be funding programs and projects.

Library Board Presentation – Don Studley, Dave Schill and Library Director Jennifer Nash presented (att).

Transfer — J. Bloom moved to transfer \$40,000 from Contingency to Repair & Maintenance (fire) (att), C Gardner seconded. Bob Tait explained that this is for removing class B firefighting foam from 3 fire trucks as well as additional funds needed to cover costly repairs. It was questioned if ARP funds should be utilized for this instead of contingency. J. Bloom moved to withdraw the motion.

T. Long moved to advise the ARP committee to consider allocating the funds required for this project to come out of the covid supplies or unallocated funds at their discretion. C. Gardner seconded. All in favor.

RESOLUTION – J. Bloom moved a resolution for an appropriation totaling \$250,000 to be used for: an outdoor playscape at the Newtown Community Center as approved in the 2024-25 Capital Improvement Plan. To be funded from the Newtown Community Center special revenue fund. D. Pisani seconded. All in favor.

RESOLUTION – J. Bloomed moved a resolution providing for an appropriation totaling \$500,000 to be used for: a new auxiliary pool HVAC system as approved in the 2023-25 Capital Improvement Plan. To be funded from the Capital & Non-Recurring fund in the amount of \$250,000 and the Newtown Community Center special revenue fun in the amount of \$250,000. B. Ruben seconded, all in favor.

24/25 Budget Discussion – K. Alexander explained that he wanted to go through the budget process. The Education subcommittee will be meeting on March 5 and March 11. The Finance subcommittee is meeting on March 4 and March 7 and the Municipal subcommittee will be meeting on March 6 and March 12.

I wanted to take second and reach out to thank you all for taking the time to consider the implications of entering into a contract with Capital tax recovery. The fact that they have subsequently walked away from this lucrative (for them) opportunity speaks volumes to what is actually happening with car taxes in the state of Connecticut, and frankly their ability to meet the commitments that they had made to Newtown.

As you may know, CT leadership has been trying to move away from the car tax for some time now – and is finally having success. The new valuation schedules for vehicles provided by the state of CT will result in dramatically lower valuations for many vehicles and thus a lower assessment. This, combined with our new lower mill rate in Newtown, makes chasing down "deadbeats" much less worthwhile that it would have been in the past. This is especially true when you factor in the 30% we would have handed over to CTR and the salaries of Newtown employees involved in tax collection.

What you may not know is that the state of CT does NOT require municipalities to tax motor vehicles as personal property – the law simply allows for it as a mechanism to raise additional tax revenue which of course just about all municipalities have done. Perhaps a more equitable way to handle this would be to stop tax motor vehicles in Newtown all together, and simply raise the mill rate to offset the loss of this revenue. Put this to a vote and see what the taxpayers have to say.

Again, thank you for not just rubber stamping a proposal that had several complex implications, including our privacy and the equity of Newtown residents, while only providing a definite economic benefit to a company that has capitalized on our states byzantine way of allowing municipalities to raise revenue.

In the latest example of the Town making it as difficult as possible for the public to participate in oversight and participation, it has come to our attention that the email link on the Economic & Community Development page of the town website does not in fact go to the members of the commission. Instead, emails sent to that address go to one town employee (who is currently out of town), and one former employee. The sender then receives an auto-reply message telling them that the former employee no longer works for the town, and they must resend their message to a new town employee.

As I'm sure the 1st Selectman knows, the ECD plans to go into executive session this Tuesday (2/20) to discuss whatever backroom deal he's been working on regarding 6 Commerce Rd., without a vote of BOS as required by our town charter.

I hope there is consensus among the BOS that the process governed by the charter should be followed, mandating the BOS to vote and approve the 1st Selectman's Proposal before it can be proposed to any other commissions, AND that in light of the public not being able to email their testimony into the ECD Commissioners prior to the meeting where they will discuss 6 Commerce Rd., there should be no executive session at this Tuesday's meeting. Subject: Process for disposing of real property (6 Commerce Rd.)

Message:

Good morning. It has come to my attention that our First Selectmen has shared his written opinion that a vote of the BOS is not required before proposing the sale or development of the taxpayer owned property at 6 Commerce Rd. (in accordance with section 8-10 of the town charter, which is included at the end of this message for reference), because he believes that the Economic Development Commission is still appointed under Chapter 132 of CT General Statutes to operate as a municipal "Development Agency"...an appointment bestowed onto them by vote of the LC in 2006 for the specific purpose of forming a development plan for the project known as the Newtown Tech Park. A portion of his recent statement is quoted below for reference:

"... a Board of Selectmen/Legislative Council designated the EDC as the development agency for the property eighteen years ago. What they are doing currently is within the scope of that appointment. When they finish their work, they will return to the Board of Selectmen with a recommendation for the property."

I reached out to the First Selectman's officer with a FOIA request for any legal opinions regarding the validity of the "Development Agency" designation today, and was told that was privileged information. I made the same request with the CT Commissioner of Economic Development in Hartford. Thankfully, they were very responsive, forthcoming and transparent. The Commissioner's office has oversight on municipal development agency appointments. Within minutes of my request, a legal staffer confirmed that our local EDC's appointment as Development Agency was limited in scope to the Tech Park Project, and because there was grant money issued to them for that project, their Development Agency designation officially ended as soon as the State forced them to reallocate the remainder of that grant money to another unrelated project (FFLD Hills). She further confirmed, that even if the appointment was still recognized by the state, and even with the "Economic Development" language attached to the land conveyance, nothing in the CT Gen Statute encourages or allows the process outlined in our charter to be ignored or circumvented.

I'm writing to ask for your help in clarifying some of the confusion in the First Selectman's office and among the Economic Development Commission. A simply vote by the LC, on a resolution to revoke the EDC's authority to act as Development Agency that was granted by the LC back in 2006 for the long-dead Tech Park project, would bring closure and go a long way. The EDC needs to understand that their appointment as a development agency ended with the Tech Park project, which would remove the fiduciary responsibility and pressure they feel encumbered by. And the First Selectman needs to understand that the process outlined below by our Charter, is the process that should be followed.

Section 8-10, Newtown Charter:

(a) The First Selectman, with the approval of the Board of Selectmen and the Legislative Council by a majority vote of its membership, may propose the Disposition of Real Property.

- 5. Fiscal 2023 and 2024:
 - Please discuss FY 2023-year end results and discuss positive/negative variance compared to the budget. Did the year perform as anticipated?

FY 2023 ended up with good results. On the revenue side the general fund ended up with a positive variance of \$431,285 (page 87 of the financials) despite budgeting the use of fund balance of \$1,300,000. In other words, we did not end up actually using any fund balance. Fund balance was used due to our fund balance policy. The use of fund balance was offset by an appropriation on the expenditure side in the transfer out – capital non-recurring account (one time capital items). Back to revenues, a negative variance in current property taxes was offset by a positive variance in other grants. This was due to the state CAP on motor vehicle taxes. To make this up they gave the towns affected a grant. Intergovernmental revenues had a positive variance due to the CAP mentioned above. Charges for services were as budgeted (for the most part) and investment income had a great outcome. A \$1.3MM positive variance! This is due to not being overly aggressive on the budget figure.

Expenditures had an overall positive experience of \$146K. The result was actually \$417K to the better at fiscal year end until the town transferred that amount to the capital and non-recurring transfer out account.

Please update 2024 year-to-date. What are your estimates for yearend general fund balance? In FY 2024 we have a planned use of fund balance of \$1,500,000 (again, offset on the expenditure side with an appropriation to one time capital items). I estimate that the town will end up using \$200,000 of the fund balance. Mainly because of a favorable balance in interest earnings (again) and intergovernmental.

On the expenditure side the town estimates to have a \$400,000 favorable balance mainly due to staff turnover and the time it takes to replace these positions.

Total general fund, fund balance at the end of FY 2024 is estimated to be \$18,000,000+ (14%) as shown in our current BOS/BOE budget proposal for FY 2025 (page 32...attached).

Discuss school budgetary performance. Is there any budgetary pressure from the sunset of ESSR grants?

The latest school budget report dated 12/31/2023 (attached) estimates a year end surplus of close to \$500,000. Positions funded by ESSR grants are now being funded in FY 2024 in the general fund. The BOE's current request for the 2025FY represents a 5.59% increase over the prior year. The overall budget increase at this point in time (in the budget process) is 4.57%. Newtown has experienced four years of practically no mill rate (effective tax rate) increases up to this point. There is budgetary pressure but not of a large magnitude.

6. 2025 and Long-Term Projections:

Discuss budgetary assumptions heading into FY 2025. How are you assuming state/intergovernmental aid?

We are in the second year of the State bi-annual budget so state revenues are more stable in the second year. We are reasonable sure that the revenues the governor has already announce will stay the same or increase. We have the governor amounts in the FY 2025 budget (that is in process). The recommended pension ARC is reflected in the budget. Employer health insurance contributions have increased 10% because of claims experience. It is a same services budget with inflation applied to it in areas. Again, the overall budget increase, at this point in the budget process, is a 4.57% increase.

Any plans to draw on reserves?

The use of fund balance in the FY 2025 budget request is \$1,200,000 which is offset on the expenditure side by an equal appropriation to one time capital items. This is the fourth year in which the town has budgeted the use of fund balance to comply with our fund balance policy (fund balance can be no more the 12% of total budget). However, because of favorable budget experience in all those years we continue to budget for it.

A handful of collective bargaining contracts expire at 6/30 - What are your expectations? Negotiations with the police union are in process. Negotiations with the emergency communications are expected to start soon. It is expected that the process will be completed in house. Very rarely does the town go to arbitration. Both contracts are expected to be completed by fiscal year end. Estimated salary increases of 2.93% for these union positions are reflected in the current FY 2025 budget request.

- 7. Have you recently experienced any turnover in key executive or financial management positions? If so, what was the principal reason for the turnover?
 - The Town has a new First Selectman who has had many years' experience on various town boards (Legislative Council and the Board of Selectmen). So he is very familiar with the town practices including the budget process and the capital improvement plan.
 - The Finance Director is retiring on 4/12/2024. The town is at the second interview point with (3) good candidates. It is planned to have a two week overlap period during which the current finance director will fill in the new finance director with current responsibilities, practices and plans.

Fairfield Hills Mixed Use

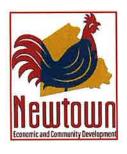






Commercial Growth

The Board of Fire Commissioners is requesting funds to cover the cost of removing class B firefighting foam. Class B foam is primarily used to extinguish flammable liquids and petroleum fires (vehicle fires). CT-DEEP (Department of Energy and Environmental Protection) has outlawed the use of class B foam because of health and environmental issues which have required the Town of Newtown and the Board of Fire Commissioners to take action to comply with this state mandate.

The Town of Newtown has three fire trucks that carry this firefighting foam that was identified as having banned additives (PSAF). The State of CT has produced a compliant procedure to rid the Town Fire Departments of this foam and has put in place a procedure to reimburse for the work performed. The reimbursement is on a first come first served basis and therefore needs to be initiated soon. Three instate companies were quoted for the work required including proper disposal as required by DEEP procedures. An amount of \$13,066.70 was lowest quoted to do the work.

The Board of Fire Commissioners will initiate this process and has funds to temporarily cover the cost from its own budget. Not knowing the timeline of the State of CT for reimbursement this money will need to be replenished so we can continue to pay expenses for the remainder of the 2023-2024 budget.

The Board of Fire Commissioners is also requesting additional funds to be added to the truck repair line item to cover unexpected costly repairs. We have had several major repairs this year. The BOFC truck repair line item is designed for annual inspections and maintenance not major fire pump and engine repairs. Because of these additional repairs we have a deficit in this account. The amount of \$25,000.00 is being requested to cover an expected deficit of \$12,000 by the end of this month with additional funds to hopefully take this account to the end of the budget year. In total we are requesting \$38,066.70
