The Parks and Recreation Commission held a virtual meeting on Tuesday, May 12, 2020 in Newtown, CT.

The meeting was called to order by Vice Chairman Patrick Barczak at 6:11 pm.

# **Public Participation:**

Ms. Jan Brown of Newtown Pickleball asked if the line painting for dual pickle ball/tennis use on the tennis courts at Dickinson Park was moving forward. Mr. Carl Samuelson, Assistant Director of Parks stated that they are third in line to have the courts slurried. They will be modifying two of the courts for pickle ball use at that time so that project should be started within two to three weeks. Ms. Brown was pleased with the response and thanked the Parks & Recreation Commission for all of their work.

# **Acceptance of Minutes:**

Acceptance of the Minutes from the March 10, 2020 meeting was put aside as there was not a quorum as Commission Chair Marks had not yet joined the meeting.

# **Correspondence Report:**

- The office received a lovely note from Girl Scout Troop #50127 thanking Brid Craddock and the entire Bike and Trails Committee for all of their support in advertising the Girl Scouts Outdoor Booklet that they have worked on tirelessly. (See attachment #1).
- Ms. Mangold has received word from Girl Scout Troop #50598, that they would like to
  present a slide show to the commission in regard to the river that runs through
  Dickinson Park. When the slide show arrives, Ms. Mangold will post it as soon as
  possible to share what ideas the young ladies have for the river. (See attachment #2).

## **New Business:**

• 2020/2021 Municipal Budget:

Due to COVID 19, the Board of Finance suggested a budget reduction for taxpayers to ease their burden. Because no public referendum was able to be held, the vote moved to the Legislative Council on May 6, 2020 as they have the authority to okay the budget without the public. That being said, The Legislative Council passed the budget unanimously.

• Summer phase-in planning and reopening:

Due to Covid 19, the spring season had to be cancelled and the office found that most participants were happy with a credit rather than a refund. Parks & Recreation is now looking at an extremely modified summer, with some virtual programs in place, sign-ups ongoing with plans in place depending on what the state will allow come summer. The first phase has been leaving hiking trails open and doing a few things virtually. The park employees have been marking trails for social distancing. Ms. Mangold believes that things may ease up a bit come May 20. Until then, the parks remain closed, but she is hopeful for the go ahead to have them partially reopened on May 20<sup>th</sup> (still no playground or dog parks opened). People would have to maintain distance, play singles tennis only, follow public policy and use common sense and police themselves. A sign will go up reminding citizens that "A CROWDED PARK, IS A CLOSED PARK", stressing that it is in everyone's best interest to stick to the recommended guidelines.

Eichler's Cove is up and running even though the beach and picnic areas remain closed. 75 of the 85 boat slips are rented, 20 out of 36 dry storage spots are rented, as well as all six of the jetski slips. Lake Lillinonah boat launch is open also. Ms. Mangold is hopeful that Eichler's Cove beach will be able to open for the season with strict guidelines in place. They spoke of the Parks Department putting up structural barriers of some sort to promote social distancing at the beach. Commissioner Clinton DePaolo asked if the lifeguards were going to wear masks to which Assistant Director of Recreation, RoseAnn Reggiano replied; "Yes, they will. Waterproof masks are on order for the guards." As far as Treadwell Pool goes, following CDC recommendations, with guidance from Donna Culbert, will be key in the decision about opening the pool. As of now, the CDC is not allowing any sports organizations to run, excluding very small group training sessions. If Treadwell Pool does NOT open to the public, P & R is considering pool use for programs such as Masters Swimming and summer swim team (with staggered time slots for social distancing purposes). Time will tell. (See attachment #3 for signage to be put up at boat launches.)

Ms. Mangold set forth a proposal for Summer 2020 Pool Pass fees to reflect the tentative nature of Summer 2020. Not only is there no go ahead to open Treadwell Pool to the

public, but a reservation system at Eichler's Cove Beach may have to be put in place as well. Because of this, Ms. Mangold proposed a half price Pool Pass for Summer 2020.

## Motion:

Commissioner Clinton DePaolo put forth a motion to accept Ms. Mangold's suggestion to offer Summer 2020 Pool Passes at half price provided a reservation system be put in place. Commissioner Warren Spencer seconded the motion, which was carried unanimously.

In the continued effort to encourage sales, Ms. Mangold shared with the commission that she and RoseAnn Reggiano discussed an All Access Pool Pass with Community Center Director, Matt Ariniello and Aquatics Director, Kristin Rebelo. They would like to offer an All Access Pool Pass for Community Center members to be able to purchase Park & Recreation Pool Passes for another half off the already reduced price.

# Motion:

Commissioner Clinton DePaolo made a motion to accept the proposed All Access Pool Pass for the Summer of 2020. This would mean an additional 50% off the already reduced price of the Newtown Parks & Recreation Pool Passes for Community Center members. The motion was seconded by Commissioner Spencer, and was approved unanimously.

Camps are allowed to start on June 29<sup>th</sup> which is a week later than originally planned. Day camps are limited to groups of 10, including the counselor with only 30 people allowed at any one site at a given time. Depending on the size of the park, up to 60 people may be allowed. Commissioner Spencer asked how that works out with the normal camp numbers, to which Ms. Reggiano stated; "That would suffice for Dickinson day camps, but the Treadwell day camp numbers are usually about 125 people per week. Registrations will have to be on a first come, first served basis." (Please see attachment #4 for special CDC website links).

In terms of Special Events that normally take place in the summer, the following concessions have been made: The Rooster Run is postponed until October. The Mad Dash is cancelled until further notice. The Summer Concert series will be going forward in some form. Right now, thoughts are moving toward a virtual concert on Tuesdays for the children and social distancing concerts for the families on Thursdays.

# Director's Report:

Amy Mangold, Director of Parks and Recreation:

- Other than the many concerns of phasing into Parks & Recreation's summer offerings,
  Director Mangold also reported that she, together with Commissioner DePaolo and
  Assistant Director of Parks, Carl Samuelson, has a scheduled call with Brad Accettella of
  the Bike and Trails Committee regarding their progress on the bicycle playground.
- Fruit and Trail committee received matching funds (of \$2,400) to be used toward educational signs and markers from the "In Your Backyard" campaign. (See attachment #5)

# RoseAnn Reggiano, Assistant Director of Recreation:

- Ms. Reggiano reported to the commission that as far as day camp goes, she is waiting (along with all the other Connecticut Parks and Recreation departments) on the Governor's Report to see if camps can open. She is also waiting on the word about hosting sports camps. "It is a waiting game right now", Ms. Reggiano said.
- In the meantime, everything is set up in RecTrac to move forward with a normal summer and many alternate, virtual programs have been researched and planned if need be. The IT Department was able to load RecTrac onto Ms. Reggiano's home tablet which has been very helpful during this social distancing time.
- People have been signing up for programs (which they are encouraging for planning purposes). Participants are aware how tentative planning is right now, and most spring participants have been fine with receiving a credit toward future programs rather than an immediate reimbursement. The department has gotten many compliments on how they have handled the situation.
- Commissioner Barczak asked if the initial date of May 20, was still in place for a gradual reopening of the parks, to which Ms. Reggiano answered, "yes".



RE: Monthly park update and field report

The Covid-19 Pandemic has obviously drastically changed our world as well as how our department has been functioning. Snow flurries on Saturday and Sunday, followed by hail on Monday has capped off a roller coaster of weather in the past month as well. Up until Monday May 11 we have been working alternating shifts, so we had a maximum of 50% staff at any given time. We have mulched the "Pleasance" with 55 yards of mulch, as we did last year as well.

<u>Dickinson Park:</u> This Park has been closed for the past month. After many unseasonably cold nights it looks like the long range forecast is warming up. We are third on our vendors list for tennis court slurry. Although I do not have any dates from him at least the weather will allow his season to start.

No new news here, fields are closed.

Orchard Hill: No new news.

Lake Lillinonah: The dock is in for the season.

<u>Oakview</u>: This field is currently closed but is looking good after sodding some worn goal mouth areas.

Tilson Field: No new news here.

Treadwell Soccer/Softball: These fields have been closed for the past month, no news here.

Glander Fields: Fields are closed, no news here.

<u>Liberty Fields</u>: No news here.

Walnut Tree: This Park has been closed for the past month, no news here.

<u>Fairfield Hills</u>: We created a "social distancing" stencil that we continually reapply after rain with chalk paint, reminding patrons to keep distanced from one another. We have completed a normal spring clean-up here as well as storm clean up following a mid-April storm. We have been sanitizing benches and dog waste bag dispensers here as well.

**NHS Fields:** This Park has been closed for the past month. The baseball field spring prep efforts look great and we are even getting some growth on the practice football field.


Sandy Hook School: No news here, fields are closed.

Hawley School Fields: No news here, fields are closed.

Eichlers Cove Marina: All of the docks have been pressure washed and installed for the season. We had to install the old access catwalk as the new one has been delayed due to Covid-19. The old unit was repaired and welded as best as possible for now. We have started weeding beds and the repurposed Warden shed has been renovated for use.

**<u>Dog Park:</u>** This Park has been closed for the past month. We have over seeded the entire park and have repaired 4 out of 5 of the water features. The 5<sup>th</sup> feature will require a significant investment if we choose to repair it.

<u>Treadwell Park:</u> The balance of the pool deck has been poured. The deck is all brand new and

<u>Watertown Field:</u> Watertown field #2 has been too wet to move on to the next steps but Public Works has begun to screen topsoil, some of which will be used here.

# Staff:

• 872 hours of vacation/sick/personal/injury/discipline hours were used out of 1680 potential work hours in the past month. This represents a 52% loss in workforce.
