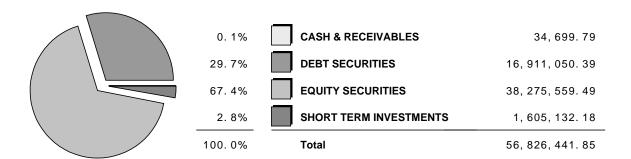

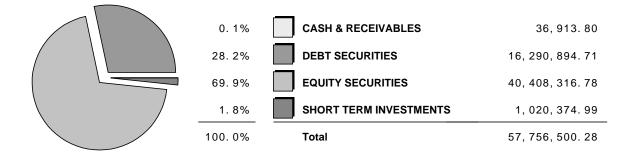

Ending Market Allocation



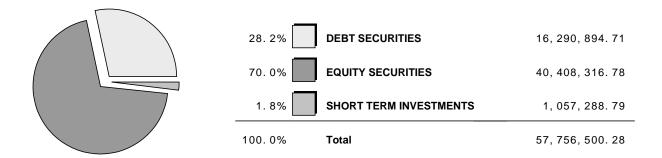

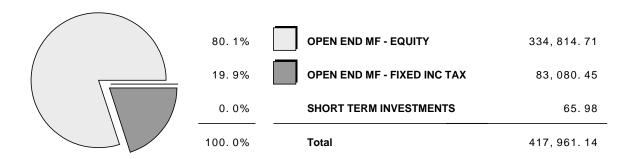

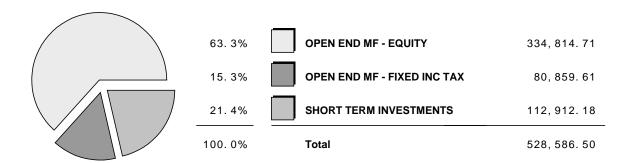
