Wells Fargo Bond Proposal - Pending

<u>Trust Asset Reports and FIA June Flash Report</u> – Patrick Burke reviewed the June 30<sup>th</sup> Year End Trust Reports and the FIA Second Quarter Performance Report. Year End Trust Balances: Pension \$39.5M, OPEB \$2.1M with annual returns of 12.7% for Pension and 12.3% for OPEB. Mr. Burke noted according to the Wilshire Trust Universe Comparison (TUCS), the median return for the fiscal year is 12.4%. The Pension and OPEB portfolios have done well for the plan year.

<u>Investment Policy Review</u> – Current IPS for Pension and OPEB are effective October 1, 2016. Pension Committee will begin annual IPS review in fourth quarter.

<u>Pension Committee Meeting Schedule</u> – Motion was made by Scott Schwartz to change the 2018 PC Monthly Meeting Schedule as follows: Committee meetings will be held every other month on the third Thursday of the month. Seconded by Charles Farfaglia, All in favor.
