### 1. Meeting called to order by Chairman Ellen Whalen at 7:40 pm.

Committee Members in attendance: Patrick Burke, Charles Farfaglia, Scott Schwartz, Ellen Whalen and Paula Wickman. Members absent: Sam Broomer and Guy Howard

### 2. Minutes

Patrick Burke motioned to approve the minutes of the October 17, 2019 meeting; Charles Farfaglia seconded. All in favor and motion passes.

### 3. Correspondence

The event Oath of Office Ceremony of Elected Officials is being held on Saturday, November 30<sup>th</sup> at 11am at the Newtown Community Center.

### 4. <u>Retirements/Expenses Payment Approval</u>

Retirements

E. Whalen advised benefit payment submitted for approval will be delayed pending resolution of question on calculation date vs payment date. Payment will be resubmitted for approval at next Pension Committee meeting.

### Expenses

E. Whalen presented the Hooker & Holcombe OPEB July 1, 2018 Actuarial Fee in the amount of \$3,100 for payment. Patrick Burke moved to approve the Hooker & Holcombe fee as presented. Scott Schwartz seconded. All in favor and motion passes.

### 5. Old Business

### Pension Interest Rate Assumption Change

E. Whalen suggested the Pension Committee consider an actuarial interest rate reduction from 7% to 6.75% in addition to a change in the salary rate assumption from 3% to 4% effective July 1, 2020. Mrs. Whalen noted her conversations with FIA, Investment Consultant, and Dave Leonard, Pension Actuary. They both feel this is a prudent consideration. Dave Leonard will begin an Impact Study in January. The rate changes will impact the Town for the 2021-2022 fiscal year. Patrick Burke suggested we consider no change at this point. Pension Actuarial Report

E. Whalen advised Committee the Pension Actuarial Report should be finalized for the February PC meeting. Dave Leonard, Pension Actuary, anticipated a 10% increase in the Town contribution due to a significant number of employee terminations during the plan year. Investment Policy Guidelines

E. Whalen presented the most recent Draft Pension Investment Policy Guidelines, dated 11/17/19, for Committee review and asked Committee Members to provide comments by December 1<sup>st</sup>. IPS will be effective 1/1/20. Mrs. Whalen thanked Investment Committee Members Patrick Burke, Sam Broomer and Guy Howard for their work in revising the policy.

### Governance Calendar 2020

Calendar reviewed by Committee. Changes suggested for first and second quarter 2020. Calendar will be approved at December PC Meeting. Mrs. Whalen will contact Hooker & Holcombe, OPEB Actuary, to schedule meeting for January 16<sup>th</sup> and TR Paul for February 20<sup>th</sup>.

### CT Public Pension Forum Meeting

Ellen Whalen, Patrick Burke and Guy Howard attended the CPPF Fall Conference October 24<sup>th</sup>. Patrick Burke provided brief overview of the meeting. Keynote Speaker Bert Brenner, SVP, People's Bank, discussed the Economic & Market Outlook. Panel discussion re ESG, an evolving approach to investments and Pension Board Best Practices was interesting and timely. Mrs. Whalen noted the Pension Board Best Practice discussion highlighted many areas where Newtown is well positioned. Our Committee is diversified with subject matter experts, meets regularly, provides committee education, oversees Trust investments with great success and initiates process improvement reviews and implementation.

### 6. <u>New Business</u>

### October 31, 2019 Market Value/Performance

Patrick Burke reviewed the 10/31 Pension and OPEB Trust Reports. Pension MV was \$48.3 million with a 15.4% YTD return. OPEB MV was \$3.1 with a 15.2% YTD return.





### Ending Market Allocation




