Old Business

457/401/Drop Plan – Update

The Pension Committee met with the Board of Selectmen December 5th. The Board approved the Committee's recommendation to transition the 457, 401 and Drop Plans to a single vendor, MissionSquare, as soon as practicable. Mr. Scott Boulton, Fiducient's Defined Contribution Consultant, will notify MissionSquare. Mr. Boulton will also advise Voya of their termination Mr. Boulton will work with MissionSquare and Ms. Patrice Fahey, Newtown HR Administrator, during the transition. MissionSquare will provide Ms. Fahey with the Transition Timeline and Next Steps. Transition will take approx. 120 days. There will be frequent meetings with participants as part of the transition.

TR Paul Review

The Committee discussed their meeting with Ms. Mary Griffin, President and Ms. Lisa Piscatelli, Administative Manager held in November. The Committee will continue to review TR Paul's services and will meet with TR Paul again in 2023 as part of the Committee's Fiduciary Governance Guidelines.

New Business

<u>Pension/OPEB Trust Market Value/Return Update – November 30, 2022</u>

The Pension Plan closed the month of November with a Value of \$55.7 million, a gain of \$2.8 million from the previous month. The portfolio is down \$8.1 million from the beginning of the year. The OPEB Plan closed the month at \$4.1 million, up \$226 thousand from the previous month and is down \$374 thousand from the beginning of the year.

The Pension Portfolio was up 5.8 percent for the month outperforming the 60/40 split (60% S&P 500 40% Bloomberg Barclays Agg) by 100 bps and underperforming the blended benchmark by 60 bps. Year to date the plan is down 12.6%, matching the 60/40 split. In general, the Plan's active managers have matched or outperformed their respective benchmarks for the year.

Real Assets, which should help add diversification as well as provide an inflationary hedge, are down -3.2 percent year to date.

Fiducient Capital Markets Review

Chair Whalen spoke with Ms. Devon Francis, Fiducient Investment Consultant, regarding the capital markets review. The Committee will meet with Ms. Francis on January 19th for the review.

Pension Actuarial Report Review

Chair Whalen spoke with Mr. David Leonard, Pension Actuary, TR Paul. The Committee will meet with Mr. Leonard during their February 16th meeting.

Other

Chair Whalen advised Committee the 2022 OPEB Actuarial Report will be finalized by April 2023. Mr. Stephan Chykirda, OPEB Actuary, Hooker & Holcombe, will review report at the May PC meeting.

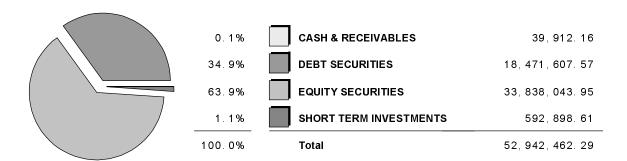

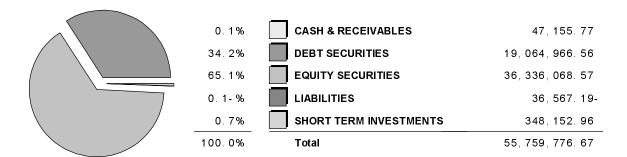

Ending Market Allocation

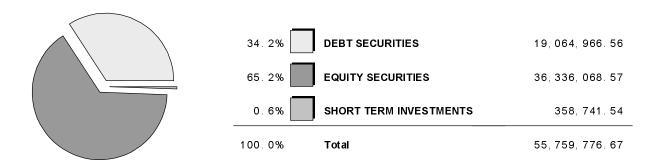
