The Sandy Hook Permanent Memorial Commission held a special meeting on Thursday, March 8, 2018 at the Edmond Town Hall, Meeting Room #2, 45 Main Street, Newtown. Chairman Lyddy called the meeting to order at 7:00pm and began with a moment of silence.

ALSO PRESENT: Bob Mitchell, three members of the public and one member of the press.

PUBLIC PARTICIPATION: none.


FEEDBACK FROM FAMILIES: Mr. Lyddy stated there were two forums for family members to evaluate the final thirteen designs and continued feedback is encouraged. Families who are out of town have the opportunity to contribute thoughts and feedback through email and by phone. The attached document outlines the feedback of thirteen families. Most were able to decide on top 3-5 designs. The feedback was positive or neutral.

Factors that need continued consideration are infrastructure, land, feasibility and cost. At this point the conversation remains on design.

There was some hesitancy relative to submitting artwork or a statement about each victim. It is believed that the families will want equal representation; all have a statement or none do. The names given to certain areas may need to be discussed further; the terminology in the narrative evoked reaction from families. There were strong opinions on the design with the 'void', for and against. The commission discussed designs with large green space.

Phase 2 presentations will be in person. Ms. Mideleer and Ms. Agni Paviliou will create a format for minimum requirement for presentation.

COMMUNITY FEEDBACK MOVING FORWARD: Community feedback will be March 15 and March 17 with the same process; in person or online. This will be advertised on the commission Facebook page, as well as the town's Facebook page and website. The feedback will be reviewed at the April meeting with the anticipation of narrowing the designs to 3-5.



Ms. Middleleer suggested allowing people to visit the site on certain days. Snow may be a factor; Mr. Lyddy said this will be re-evaluated over the next couple of weeks. Once the short list is decided upon they can be sent to the PD for review in regards to security. The next commission meeting is April 12, members should have an idea of their top 3-5 designs. At the end of the meeting, after reviewing community and family feedback, 3-5 designs will be chosen. The advisory members will be invited. The final designs will be sent to Parks & Recreation, Police Department and the Police Commission.
