On August 15th 2016 the Newtown Police Department received information that a threatening telephone call had been received at the main office of Sandy Hook Elementary School. The caller asked when the first day of school was, and after being provided that information made a threat against Sandy Hook School for that day (August 29th). An investigation into the phone call was immediately begun. A telephone number originating from a nearby town was quickly identified.

An exhaustive investigation was completed after the local phone number brought investigating SRO (School Resource Officer) William Chapman to a national mobile phone company outside of Connecticut, then to a company in Canada. SRO Chapman was able to identify Pierre Beauvil as the caller who made the threat towards Sandy Hook Elementary.
