OLD BUSINESS:

Follow-up From Previous Meetings

- Shelia Torres sent a spreadsheet from her system to track remaining life of Equipment at Edmond Town Hall. The system is *eSpace* from Smart Church Solution, Inc.
 - Ned S will draft a general comparison of Dudes and *eSpace*.
- Definitions discussed:
 - Document types “Initial Inspections” and “Warranty” will be related to a facility. After the initial load, inspections would be reported via Maintenance Reports
 - If a facility does not have wings, the “Wing” field will be “Original Building” if a facility has wings, “Main Building” will be used
- Discussed glitches and enhancements

Discussion: Purpose, design, and development of a Town building inventory

- Discussion of Newtown Information System (NIS) Prototype.
 - The group collectively worked on loading data for the Police Station.
 - Some glitches were identified
 - Need to load the automated gate between civilian and police parking and generator
 - Need to conform how Ductless splits are entered. Allen A will follow-up as to whether to use Air Handler or Air Cooled Condensing Unit
- Discussed the challenge of Data Quality assurance.
- Discussed the pace of data entry for the Police Station, slower than expected and the need to prioritize loading. Ned S to provide a summary of CIP requests that would tie to the Building Inventory
- Brief discussion of workflows for Work Orders and maintenance reports.
 - Conference call (Zoom) with GIS Specialist, Bob G, Graham C and Dude Solutions (technical folks) scheduled for March 10.
